standby. The mother and owner of the residence, Helen Collins W/F 12/5/31, was released from the hospital. Her son, Richard Collins W/M 9/17/59, was taking his mother home and requested a civil standby. R. Collins advised me that his sister, Lisa Feuer W/F 1/8/66, who has been living in this residence and is supposed to be taking care of her mother. Feuer was getting intoxicated in which they initiated a DCF case reference to abuse and neglect. See Officer Quiros' report 20002858. R. Collins said he was told to contact Jupiter Police for a civil standby when returning home. I made contact with all three of the above during the civil standby and advised them all to keep the piece. I gave advice reference to expectation of residency and the eviction process. All was calm upon departure.

Upon arrival, I made contact with R. Collins who appeared the same as I last saw him however, he was holding a cloth with ice in it to his lower left lip. He was calm and was able to answer all my questions quickly and thoroughly. He refused medical treatment. I checked on H. Collins who was sitting in a chair. She said she was not involved in the fight between her son and daughter. She did witness the incident. Officer Morgan made initial contact with Feuer in her bedroom.

H. Collins provided me with a sworn statement captured on my BWC. She told me the following: she told her daughter to leave for a few days. She arranged for her to stay in a Holiday Inn. She wanted her to leave because she gets too drunk to take care of her. In fact, they called DCF on her. She was standing in the foyer between the bathroom and Feuer's bedroom as well as R. Collins. Feuer was packing and changing her mind about leaving. Feuer asked R. Collins to take pictures as proof she was leaving. That's when Feuer had an anger outburst and charge at R. Collins swinging her arms. She was not certain how R. Collins was hit but saw Feuer go after him swinging her hands at his face.

R. Collins provided me with a sworn statement captured on my BWC. R. Collins told me the following: he and his mother were in the foyer at Feuer's bedroom door. They were trying to get Feuer to pack and move out for the night. Feuer was changing her mind back and forth whether to move out or not. He was using his cell phone to video conference with his brother in another state to show him what was going on. Feuer who was already angry wanted him to stop recording him. Feuer came at him with her cell phone in her hand and struck him on the mouth with the phone. He said it was unexpected and she "clock me." He showed me a video captured on a in home security camera. He backed away from her and called 911. Feuer went back to her room and closed the door.

The video showed Feuer aggressively moving towards him flailing her arms. The video did not show him get hit but it did depict what both R. Collins and H. Collins told me in there sworn statement.

I made contact with Feuer in her bedroom. She was sitting on her bed and her room appeared to be in disarray, possibly from packing. Her clothing was disheveled and her hair was a mess but tied up. Her answers were slow as if she had to think about them. She changed the subject when I asked certain questions. I would ask a question she would give a limited vague answers. I asked her to elaborate several times. I did not smell an odor of an unknown alcoholic beverage.

I spoke with Feuer who provided me with a sworn statement captured on my BWC. After I left her house, her brother threatened her. The threats were on her text messages and she would have to check them to elaborate. When I asked about the texts, she change the subject asking about how her mother was doing. She said he, R. Collins, got in her face. I asked what did he do when he got in your face. She replied, "He's very intimidating." She went on about his size and said he threatened her. She said he did not touch her but he's

intimidating because of his size. I asked why she did not call the police on her phone rather than his her brother with it. She replied, no, I threw the cell phone. I said either way you still hit him right. She replied sarcastically, "OK, I'm gonna cry all night about that." Again, I asked, why you did not call 911, she replied, "So I'm the bad person here." She said, "He pissed me off." I asked how he pissed her off and she replied, "I can't answer those questions."

It was determined that probable cause exists to charge Lisa Feuer with Battery.

Lisa Feuer did actually and intentionally touch or strike Richard Collins against the will of Richard Collins (or) did intentionally cause bodily harm to Richard Collins and Richard Collins was a family or household member of Lisa Feuer, contrary to Florida Statute 784.03(1)
