The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 11/03/2019, at approximately 0130 hours, at Memorial Hw / Veterans Northbound, Tampa, FL 33607, Deputy Ryan #257245 conducted a traffic crash investigation (see HCSO case #19-789716 and DHSMV crash report #89132655-01) involving a 2004 white Nissan pick-up truck, FL tag: IQVF36 / VIN: 1N6AA06AX4N510735). The witness observed the defendant behind the wheel of the above listed vehicle. I noted the defendant had a severe odor of an alcoholic beverage coming from his person, bloodshot watery eyes, was very unsteady on his feet, and was swaying while standing still. The defendant was given the opportunity to perform field sobriety exercises, which he did poorly, indicating impairment. Subsequent to arrest, the defendant provided breath samples of .214 / .198 BAC (after a twenty minute observation period). The defendant was identified via his Florida driver's license.
