On May 10th, 2020 at approximately 0808 hours, I arrived at 7859 Patriot Street in Unincorporated Lake Worth Florida 33462, Capistara subdivision, in reference to a domestic dispute.

I spoke with the victim, Patricia Rojas, who told me the following: She was laying in her bed in her bedroom when the defendant, Lizabeth Rojas, opened her bedroom door and came inside. Lizabeth Rojas began yelling and pulling on the baby, Lilah Rojas. Patricia Rojas got out of bed where the tussle for the baby continued. Lizabeth Rojas pulled the baby away. Lizabeth Rojas then kicked Patricia Rojas about 6 times in the stomach. Lizabeth Rojas picked up a tv remote control and struck Patricia Rojas in the head about 4 times. Patricia Rojas stayed in the room with Lizabeth Rojas telling her not to do this until the police arrived.

I spoke with Marcos Rojas who told me the following: He is married to Lizabeth Rojas. On 05/10/20, Lizabeth Rojas came to his mother's house and started to bang on the door. After a brief confrontation, Lizabeth Rojas pushed her way into the residence and went into Patricia Rojas' bedroom. Marcos Rojas witness the struggle over the baby between Patricia Rojas and Lizabeth Rojas. He saw Lizabeth Rojas kick Patricia Rojas multiple times and then strike her with a tv remote. Marcos Rojas tried to stop her and also called the police.

I read Lizabeth Rojas Miranda Warnings and she understood them. She told me the following: She came over Patricia Rojas' house to pick up her daughter for Mother's Day. Lizabeth Rojas and Marcos Rojas had an agreement that Lizabeth Rojas would pick up her daughter to spend Mother's Day together at 0600 hrs. Marcos Rojas started yelling at her and wouldn't let her inside. Lizabeth Rojas pushed her way inside and went to where she knew her baby would be. Lizabeth Rojas opened Patricia Rojas' bedroom door and demanded her baby. Patricia Rojas wouldn't give the baby to her. Lizabeth Rojas pulled on the baby to get her from Patricia Rojas. Lizabeth Rojas pulled the baby away. Lizabeth Rojas picked up a tv remote. Lizabeth Rojas stated she threw the remote control. Lizabeth Rojas refused to answer anymore questions or be more specific about what occurred at this point.

Based on the above stated information I have reason to believe and do believe the defendant, Lizbeth Rojas, violated F.S.S. 784.03(1a1); Battery.
