On the above listed date and time at the above listed location, Deputy Juncal #253879, conducted a traffic stop on a silver Honda Accord bearing Florida tag: Z654NW, for violation of 316.072(3), disobedient to and effect of traffic laws. Upon making contact with the defendant, Deputy Juncal observed signs of impairment. I responded to the scene, detected the defendant to have glassy eyes and a distinct odor of an alcoholic beverage emanating from his breath. I requested the defendant to perform Standard Field Sobriety Exercises (SFSEs), which the defendant agreed to perform. After performing the first exercise (HGN), the defendant refused to perform the rest of the exercises and was subsequently arrested for DUI. The defendant refused to provide two lawful breath sample to determine his breath alcohol content (BrAC). I read Implied Consent to the defendant in room #1 of Central Breath Testing, he understood and replied "I'm not blowing". The defendant received a DUI citation #AE94S9E, which reflects the DUI charge. The defendant was identified via his Florida Driver's License.
