The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 07/18/2021, at approximately 2156 hours, Deputies responded to the above mentioned area in reference to a complaint of a reckless driver. Deputies located the subject vehicle, which had crashed into a private residence (HCSO Case #21-475912/ DHSMV #89450471). The estimated total damage as a result of the accident was \$1,100. The witness positively identified the defendant as the person who was operating the vehicle at the time of the accident. Upon contact with the defendant, the affiant detected to the distinct odor of an alcoholic beverage emanating from her breath, observed her eyes to be blood shot and watery, her speech to be slurred, her movements to be slow and lethargic, and her to fumble for requested documents. The affiant requested the defendant to perform Standard Field Sobriety Exercises (SFSEs), which the defendant agreed to do. During the SFSEs, the defendant exhibited multiple signs of impairment and was subsequently arrested for DUI. After a proper 20 minute observation period was conducted, the defendant agreed to provide two lawful samples of her breath. Breath Technician N. Greenlee (ABN:228570) provided the affiant with the results and they are as follows: first BrAC sample .218%, second BrAC sample .213%. The defendant was positively identified via DAVID photo taken 04/23/2018.
