The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did Between 3/29/2020 and 4/3/2020, at 611 Destiny Dr, Room 214, the defendant and victim were staying together in the hotel room. The defendant and victim had several loud arguments according to hotel staff. The affiant made contact with victim and observed the victim to have redness and swelling around each eye, bruises on her arms and a large contusion on her hip area. Over the four days that the defendant and victim stayed in the hotel room together, the defendant intentionally and against her will struck the victim in her face several times with a closed fist. The defendant also picked up the victim and slammed her into the bed which is made of solid wood. The victim sustained several substantial injuries, but the extent could not be determined because she refused medical treatment. The victim and defendant have lived together at different times and are romantically involved. The victim identified the defendant as the person who committed the offense. The defendant was identified using his North Carolina Driver License. The defendant and victim reside out of state and do not have any ties to Hillsborough County.
