The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 The victim and the defendant have been married since September 2019 and have been living together since then. On Saturday, February 27, 2021 the two engaged in a verbal argument over the victim's suspicions that the defendant has been engaging in prostitution.

The victim grabbed a commonly shared cellphone from the defendant's grasp and she jumped on him. While doing so the defendant scratched the victim's right arm and bit the webbing of his right hand, between his thumb and index finger. The victim suffered marks and broken skin. These injuries did not require medical attention. The victim attempted to deescalate the situation by walking away when the defendant again jumped on him a second time. The victim and this son left to avoid further violence. These events occurred in the presence of the victim's 11 year old child; to whom the defendant has no biological connection.

The victim identified the defendant via her Puerto Rico Identification card.
