During the text communication the defendant asked if the witness would do an "incall" which is street terminology for having sex in the provider's hotel room. During the text communication the defendant also agreed to pay \$120.00 in US currency for the witness services. The witness provided the hotel address and room number to the defendant. Once in the room, the defendant engaged into casual conversation with the witness but did not solicit a sexual act. The defendant indicated that he was nervous and told the witness " Lets get undressed and we will go from there". The defendant paid in full, at which time the witness provided the predetermined take down signal and the take down team detained the defendant for further investigation. Post Miranda, your affiant interviewed the suspect who indicated that his intentions was to have sex with the witness for \$120.00. The defendant identified himself verbally.
