


On the **11** day of **November**, **2019** at **16:41** (Specifically include facts constituting cause for arrest.)

On Sunday October 27, 2019 at approximately 2046 hours, I was working in a Uniform Capacity assigned to the Patrol Division when I was dispatched to 699 Brandon Prescott Lane reference a domestic battery (delayed).

Upon arrival I made contact with the victim Tabitha A. Dudak W/F 08/05/1998 (identified by FL Driver's License). She advised that she was in a physical altercation with her boyfriend of 2 years Luis Puentes (unknown DOB) at her residence (833 Millbrae Ct). Dudak advised that they lived together for approximately 2 months and do not have any children in common. Dudak advised that she only had a partial date of birth for Puentes (February 8th or 9th) and that he was 31 years old. Upon searching LE databases, I located a male matching that description Luis Puentes W/M 02/08/1988 (P532521880480).

Dudak stated that she purchased a Roomba vacuum from Offer Up on Friday October 25, 2019 and Puentes got upset with her about that purchase. Dudak advised that Puentes would frequently accuse her of cheating and lying. Puentes told her that "you never need to go on Offer Up again, but if you do you won't be dating me". Puentes brought up something about location sharing and the fact that he did not know where she was. Dudak stated that she attempted to share her location, but it did not work properly. Puentes then started screaming at Dudak in her face and Dudak ended up pushing him on the arm to move him away from her. Puentes wanted to talk to Dudak, but she told him she needed some space. Dudak stated that they separated for about 30 minutes or so and then he came back in her direction and got in her face. Puentes proceeded to push her onto the floor causing her to injure her head. Puentes came towards her quickly and punched her in the face (nose area). Dudak knew immediately that her nose was broken. I observed the injury to Dudak's nose and the discoloration surrounding the area. Dudak's nose had noticeable disfigurement even days after the incident. Dudak stated that she told Puentes that she needed to go to the hospital ER because of her nose injury. At first, Puentes told her that he would just YouTube to figure out a solution to the injury.

<p>Eventually Puentes ended up driving Dudak to the Emergency Room at Good Samaritan Hospital. Dudak advised that she did not notify the staff of the incident because Puentes was present with her the entire time. She was unable to discuss the incident in detail and provided an excuse to the staff about her injury. Saturday October 27th and Sunday October 28th, they were involved in more verbal arguments about their relationship issues. On October 28, 2019, they were arguing and Dudak ended up driving to Home Depot area and getting out of her car to speak with Puentes. Once Dudak got out of her vehicle, Puentes started yelling at her while she carried her I-phone in her right hand. Somehow through all of the arguing, Dudak's phone was dropped out of her hand in the process. Dudak advised that she did not believe that Puentes caused the damage to the phone.</p> <p>I then made contact with Dudak's friend Kristina Hall W/F 11/22/1988 who provided a sworn statement indicating that Dudak sent her a photograph immediately after the incident. Hall advised that Dudak sent a text message stating that Puentes punched her and broke her nose not to call or text because he would get upset. Hall emailed me the photograph and it was uploaded to evidence.com</p> <p>Dudak described Puentes as a Hispanic male, brown hair, brown eyes, approximately 5'07-5'08 and 160 pounds. Dudak is approximately 5'02 and 120 pounds. Dudak was shown a DAVID photograph of Puentes and she positively identified him as the individual that pushed her to the ground and punched her in the face. She circled and initialed the photograph.</p> <p>Based on Dudak's injuries I find probable cause to arrest Puentes for Felony Battery pursuant to F.S.S. 784.041(1). The victim (Dudak) has experienced facial disfigurement to her nose area (curvature) that will require multiple medical treatments and services.</p> <p>My BWC was active.</p>
