The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 12/26/2020, at approximately 1124 hours, the arrestee was observed by deputies responding to a DUI call for service to be the sole occupant seated in the driver's seat of a parked Kia Soul bearing Florida license plate 2371TL (Assigned VIN KNDJ22AU1L7700942). The vehicle was parked on the side of the road in the roadway with the yellow hazard flashers on. Observed in plain view, without entering the vehicle, were multiple red in color Budwiser cans that were located on the floor behind the driver seat. The same Budwiser can was also located on in the grass approximately 10 feet from the vehicle along with 2 (two) 50 mL 99 Black Cherry liquors. Upon the affiant making contact with the arrestee, the distinct odor of alcohol was detected emanating from his person and he was unsteady on his feet. The arrestee agreed to perform Standardized Field Sobriety Exercises (SFSE's) during which signs of impairment were observed. Upon arrival at Central Breathe Testing, the arrestee refused to provide two lawful breath samples after being read Implied Consent. The arrestee's identity was confirmed via Florida Driver's License.
