at approximately 10:13 PM, at 100 4TH ST S, in Pinellas County did:

DID THEN AND THERE ENGAGE IN SUCH CONDUCT AS TO CONSTITUTE DISORDERLY CONDUCT, TO-WIT: THREATENING TO FIGHT PEOPLE IN THE ESTABLISHMENT, AND THROWING BOTTLES AT PEOPLE INSIDE OF THE ESTABLISHMENT, WHICH CONSTITUTED A BREACH OF THE PEACE.

ON THE ABOVE DATE AND TIME, I RESPONDED TO PARK AND REC IN REFERENCE TO A DISORDERLY CONDUCT. UPON ARRIVAL, I OBSERVED THE DEF BEING HELD ON THE GROUND BY FOUR SECURITY GUARDS. WIT1 STATED THAT THE DEF WAS IN A VERBAL ALTERCATION WITH PEOPLE INSIDE OF THE BAR. WIT1 STATED THAT THE DEF BEGAN TO THROW GLASS BOTTLES FROM OUTSIDE OF THE ESTABLISHMENT, AT PEOPLE THAT WERE INSIDE OF THE ESTABLISHMENT. WIT 2 STATED THAT THE DEF THEN JUMPED THE FENCE INTO THE ESTABLISHMENT, AND SWUNG ON ANOTHER WITNESS, THAT WAS INSIDE OF THE BAR.

POST MIRANDA, THE DEF STATED THAT HE THREW BOTTLES ON THE GROUND OUTSIDE THE BAR BECAUSE HE WAS ANGRY. THE DEF STATED HE JUMPED THE FENCE INTO THE BAR BECAUSE HE WAS AGITATED.

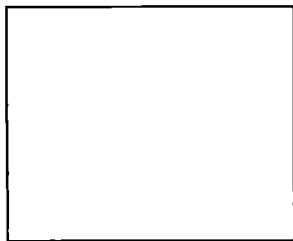
