On the 30 day of January, 2021 at 02:16 (Specifically include facts constituting cause for arrest.)

On 1/30/21, at approximately 0150 hours, I was parked in front of 234 S Federal Hwy (The Black Rose Irish Pub) when I observed a w/m subject exit the bar, stumble to a gray Mercedes Benz sedan in a nearby parking lot, sit in the driver's seat, and begin to drive away. I placed my unmarked BRPD vehicle behind the gray 2004 Mercedes Benz E-320 (TX tag KKG1373) as it exited the parking lot and began observing the driver's driving pattern. The driver had difficulty establishing a lane as it approached the intersection at 3rd St and S. Federal Hwy. He then made a right turn to head north on Federal Hwy and was driving in the bicycle lane. The driver then went all the way to left and made a U-turn to travel south on S Federal Hwy. I then observed the driver approach a red light at the intersection of S. Federal Hwy and SE Mizner Blvd and continue through the intersection without stopping. I conducted a traffic stop on the vehicle and it came to a final stop in the area of 50 SE 7th St.

I approached the vehicle from the driver's side and made contact with the driver, Luke Jorris. I immediately observed that Jorris had red glassy eyes, slurred speech, and a strong odor of alcohol emanating from his breath. I asked if he knew the reason for the stop and he confessed to running the red light. I then asked Jorris if he consumed any alcohol and he confessed to drinking two "seltzers". Jorris initially stated he consumed Truly's but later told me he consumed White Claws. He also stated he was coming from a friend's house but then confessed to being at the bar after I told him I saw him walk out of the bar. During this time, Officer Codling was standing at the passenger side of the vehicle and told me there was an empty bottle of vodka on the passenger floorboard.

Based on my observations, Jorris' driving pattern, and Jorris' statements, I asked Jorris to step out of the vehicle for further investigation. I observed Jorris required support from the vehicle while stepping out. I then asked him to submit to Standardized Field Sobriety Exercises and he agreed to participate.

Prior to beginning the exercises, I asked Jorris a series of questions. I asked Jorris if he was sick or injured and he stated he was not. He also stated he did not have any physical defects or injuries. Jorris claimed he did not limp and felt comfortable in the shoes he was wearing. I asked if Jorris was taking any medication and he stated he was not. Lastly, Jorris advised he was not diabetic or epileptic, and he did not have anything wrong with his eyes that is not corrected by glasses. I then continued with the exercises.

The first exercise was Horizontal Gaze Nystagmus. I administered the instructions and Jorris stated that he understood. I observed that Jorris swayed in a circular motion during the exercise.

The second exercise was the Walk and Turn. I administered the instructions and demonstrated how the exercise should be completed. Jorris stated that he understood. Jorris had difficulty getting into the starting position and began the exercise prior to being told to do so. While taking his steps, I observed that Jorris missed heel-to-toe numerous times and fell off the line. He also failed to count his steps out loud.




The third exercise was the One-Leg Stand. I administered the instructions and demonstrated how it should be completed. Jorris stated he understood. Jorris swayed, placed his foot on the ground several times, and failed to count aloud during the exercise. He also stopped prior to being told to do so.

The fourth exercise was the Finger to Nose. I confirmed that Jorris knew his left from his right by asking him to show me his left hand and then his right hand. I then administered the instructions. Jorris stated he understood. The pattern was L-R-L-R-R-L.

- L - Missed tip of nose and placed finger under nostril.
- R - Missed tip of nose and placed finger under nostril.
- L - Missed tip of nose and placed finger under nostril.
- R - Missed tip of nose and placed finger under nostril.
- R - Missed tip of nose and placed finger under nostril.
- L - Missed tip of nose and placed finger under nostril.

The fifth exercise was the modified romberg balance test. I informed Jorris that he would need to estimate the passage of 30 seconds with his eyes closed and his head tilted back. I demonstrated the passage of 30 seconds using a stop watch. The instructions were administered, and the exercise was conducted. Jorris estimated the passage of 30 seconds in 32 seconds.

Based on the totality of the circumstances, I found probable cause to believe that Jorris was operating a motor vehicle while under the influence of drugs or alcohol. Jorris was placed under arrest for DUI per F.S.S 316.193(1).




A search of the vehicle incident to arrest revealed an empty bottle of Deep Eddy Vodka (750ml), a nearly empty can of Mike's Hard Seltzer (12oz), a nearly empty can of Bacardi Lime and Soda Special Rum Cocktail (12oz), and an empty can of Twisted Tea (24oz) within the passenger compartment.

Jorris was then transported to the Palm Beach County Sheriff's Office DUI Testing Facility where Breath Operator Bell (#8656) conducted the BAT room procedures. Jorris was asked to provide a breath sample and he refused. I informed Jorris of implied consent and he again refused to provide a breath sample. He was advised of his constitutional warnings, advised he understood, and chose to not answer any of my questions. He was later turned over to PBSO. See the DUI influence report for further.

While sorting Jorris' property, it was discovered that he was in possession of a fake Texas Driver's License which displayed a birthday of 04/23/1999 instead of his actual birthday of 04/23/2002. He is additionally being charged with Possession of a Fake Driver's License per F.S.S. 322.212(1c). The fake Driver's License was submitted to BRPD evidence.

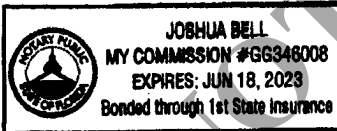

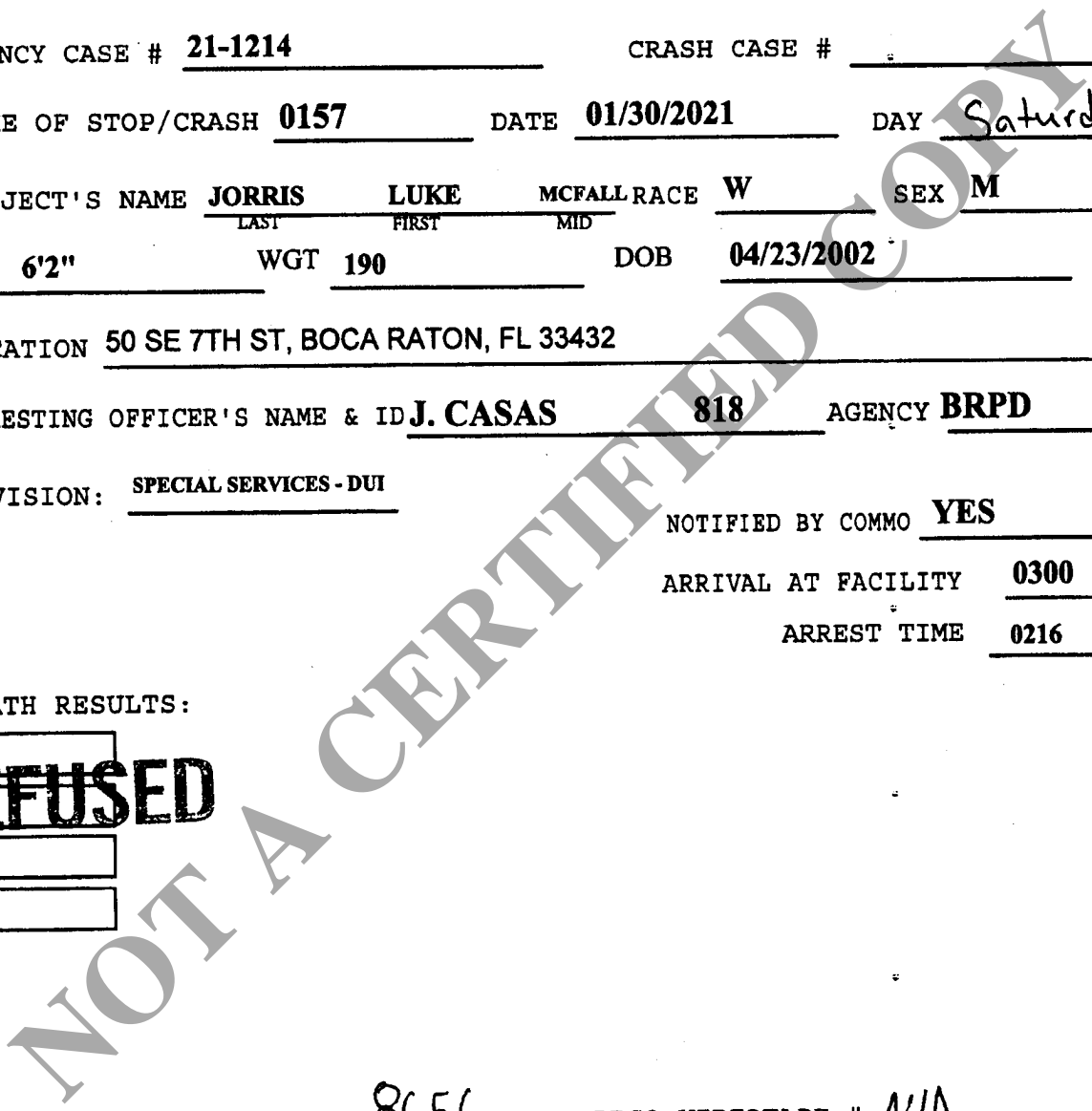

Additionally, if you refuse to submit to the test I have requested of you and if your driving privilege has been previously suspended for a prior refusal to submit to a lawful test of your breath, urine or blood, you will be committing a misdemeanor. Refusal to submit to the test I have requested of you is admissible into evidence in any criminal proceeding.
