

(Specifically include facts constituting cause for arrest.)</p> <p><b>On July 31, 2021 at approximately 2015 hours, while on scene of a traffic crash at State Rd 7 and Business Pkwy in the Village of Royal Palm Beach, Palm Beach County, FL, we were notified that a hit and run crash had occurred in the area of State Rd 7 &amp; Belvedere Rd. Sgt. Manning #13558 made contact with the driver and passenger of the victim vehicle, a gray Nissan Altima bearing FL tag #NZR-V74. The occupants told Sgt. Manning that a dark green Toyota Tacoma pickup truck bearing FL Tag # Y40-MLL had just rear ended them and was fleeing the scene. Sgt. Manning advised both the driver and passenger pointed out the vehicle as it was driving away northbound on State Rd 7.</b></p> <p><b>D/S Quevedo (ID #12783) was able to catch up to the Toyota Tacoma and initiated a traffic stop. I then responded to the traffic stop to conduct a traffic investigation. It should be noted that D/S Quevedo and Sgt. Manning both observed the driver inside of the vehicle, operating the vehicle, and was the sole occupant therein. Sgt. Manning and D/S Quevedo identified the driver as Luke Rigg, who stated to them that he had been drinking at least 3 beers prior to driving and had more beer in the car.</b></p> <p><b>I first spoke with the driver of the Nissan Altima, Alexandra Agate, and the passenger, Kayla Agate. Alexandra stated she was driving northbound on State Rd 7 just north of Belvedere Rd. Alexandra was moving over to the right lane as she saw the lanes of traffic being blocked due to another traffic accident when she was all of sudden was jolted forward and heard a bang. Alexandra stated that she realized she had just been rear-ended and turned around. She then saw a white male, with facial hair driving the green truck that hit her vehicle. She put her hazards on and attempted pull to the side when she realized the driver of the green truck was leaving the scene. Alexandra was able to get a license plate of the vehicle to assist deputies.</b></p> <p><b>Kayla concurred with her sisters statements but added to her statement that she called 911 dispatch giving them the tag number of the Toyota. Both Kayla and Alexandra provided sworn written statements.</b></p> <p><b>I then spoke with the driver of the green Toyota Tacoma, Luke Rigg. Luke was already in the backseat of D/S Quevedo's patrol vehicle. D/S Quevedo advised that as he walked up to the driver's side door, he noticed the odor of unknown alcoholic beverage emanating from the vehicle as well as his body and breath. He saw an open Bud-light tall boy (24oz beer can) on the floor of the passenger seat. The can was cold to the touch and still had liquid inside that smelled like alcoholic beverage. He also saw an open pack of Heineken beer on the floor of the passenger seat with several bottles open and empty. He spoke with Luke and asked if he was injured from the accident and why he did not stop. Luke stated that he only lightly struck the other car and admitted to drinking approximately 3 beers. Luke's eyes were very glossy and bloodshot. D/S Quevedo attempted to conduct a DUI investigation with Luke, offering for him to submit to roadside tasks, to which he refused. Luke was placed in handcuffs which were checked for proper fit and tightness and placed in the rear of my patrol car.</b></p> <p><b>****CONTINUED ON PAGE 2****</b></p>

Alexandra was read admonishment prior to the show-up and 100% positively identified Luke Rigg as the driver of the vehicle that struck her car and fled the scene. It should be noted that Luke was photographed inside of the vehicle prior to him exiting the truck.</p> <p>I then observed both the Toyota Tacoma, to which I saw that the truck had front end damage consistent with rear ending another vehicle and a slight amount of silver paint transfer. I further observed Alexandra's vehicle (the Nissan Altima) and saw that it had scratches and scuffs throughout the rear bumper with a small bit of dark paint transfer consistent with being rear ended up the Toyota Tacoma. The estimated damage to the victim's vehicle is approximately \$500. The vehicles were photographed and the photos entered into evidence.</p> <p>I then transported the defendant, Luke Rigg, to the PBSO Breath Alcohol Testing Facility in order to request a breath sample pursuant to my DUI investigation. Upon doing so, Luke Rigg refused and then was read his Taylor warnings. Luke Rigg stated he understood and refused to submit to a breath test. A records check was conducted, to which Luke Rigg was determined to have one (1) prior conviction for DUI on 08/08/2011. A traffic crash report was also completed under PBSO case # 21091385.</p> <p>Based on my investigation, I determined that Luke Rigg did commit the following crimes:</p> <p>DUI - by knowingly and willfully operating a motor vehicle within the State of Florida, while under the influence of drugs and/or alcohol, and refusing to submit to roadside tasks as well as breath test, all with a prior conviction for DUI, pursuant to FSS 316.193(1)</p> <p>Leaving the Scene of a Crash with Property Damage - by knowingly and willfully being involved in a traffic crash where his vehicle struck the victim's vehicle in a front to rear collision, to which he then fled the scene without exchanging information, pursuant to FSS 316.061(1).</p> <p>The subject was booked at the Palm Beach County Main Jail without incident.</p>
