The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 22 day of APRIL, 2020, at approximately 10:02 PM, at 201 GULF BLVD, BELLEAIR BEACH, in Pinellas County did:

THEN AND THERE UNLAWFULLY HAVE IN HIS POSSESSION, CUSTODY, OR CONTROL A CERTAIN CONTROLLED SUBSTANCE, TO-WIT: CANNABIS SATIVA, COMMONLY KNOWN AS MARIJUANA.

THE DEF WAS STOPPED DUE TO DARK TINT ON THE CO-DEF'S VEHICLES WINDOWS. THE STRONG ODOR OF MARIJUANA WAS EMITTING FROM THE VEHICLE. THE DRIVER ALSO HAD A SMALL CLUMP OF MARIJUANA "SHAKE" BEHIND THE DRIVER'S SEAT. THE DEF ADVISED SHE DOES NOT USE HEMP AND DOES HAVE A MEDICAL MARIJUANA CARD, BUT THE PRESCRIPTION IS EXPIRED. THE DEFS HAD APPROXIMATELY 170 GRAMS OF MARIJUANA IN VACUUM SEALED BAGS IN THE BACK OF THE VEHICLE. THE DEF ADMITTED POST MIRANDA TO PURCHASING THE MARIJUANA FOR APPROXIMATELY \$900 USD, SPLITTING THE COST WITH HER BOYFRIEND, THE CO-DEFENDANT.

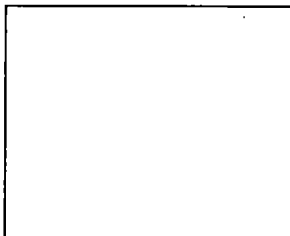
