On 03/05/2022 at approximately 0523 hours, this Officer was dispatched to the area of Alt A1A and Burns Rd, PBG, FL, in regard to a reckless driver. Body worn camera and in car video were used.									
The anonymous caller advised dispatch of a black or dark blue Audi driving south bound in the north bound lanes of Alt A1A. The caller further advised the vehicle was stationary at the intersection then east bound on Burns Rd. The caller then said the vehicle was swerving in the east bound lanes and advised he was in a silver Ford F-150. This Officer proceeded to the area and located the F-150 following a dark color Audi utility (ITTN61/FL), at a far distance. This Officer passed the F-150 and got behind the Audi in the outside through lane, in the area of Burns Rd and Sandalwood Cir, PBG, FL. This Officer observed the Audi to be driven very carelessly and unable to maintain a single lane. The Audi then made an abrupt U-turn in the 2500-block of Burn Rd.									
This Officer was very concerned for the Audi drivers well-being as well as others potentially in its path, which forced this Officer to initiate a traffic stop on the vehicle just east of Alamanda Dr. This Officer made contact with the driver and sole occupant of the vehicle, identified via Florida Driver License photo, Mahesh Deshmane (OF) while he was still in actual physical control of same. Deshmane appeared disoriented and highly intoxicated. Deshmane had low heavy eyelids, thick slurred and mumbled almost unintelligible speech, and delayed reactions to questions and commands. The only odor this Officer was able to detect was body odor. Deshmane provided this Officer with his license and health insurance card. When asked for auto insurance, Deshmane was unable to provide. When asked where he was coming from, Deshmane said he made a U-turn and was going home. This Officer asked again and Deshmane said he was coming from "downtown". Deshmane denied consuming alcohol on this night.									
Based on this Officers observations, Deshmane was asked to exit the vehicle to

participate in Standardized Field Sobriety Exercises, to which he complied. Once Deshmane exited the vehicle, he stumbled, lost his balance and almost fell. Deshmane walked to the rear of the vehicle with a very unsteady stride. Deshmane said he did not have any medical conditions which would affect the exercises conducted. Deshmane further advised he was diabetic.

The first exercise conducted, was the Horizontal Gaze Nystagmus. The stimulus used, was a Streamlight Stylus. This Officer observed lack of smooth pursuit in both eyes and sustained involuntary jerking in both eyes at maximum deviation, as well as the onset of Nystagmus prior to 45 degrees in both eyes. Deshmane had to be told multiple times to properly follow the stimulus.

The next exercise conducted, was the Walk and Turn. The line used was a strip of yellow tape placed upon the pavement by this Officer. Deshmane had great difficulty getting into and remaining in the starting position. Deshmane had to be instructed several times the proper form of the starting position. Deshmane also started the exercise prior to being told to do so. During the first set of steps, Deshmane missed heel-to-toe on each step and paused to regain his balance during the attempt. After the ninth step, Deshmane stumbled off the line. Deshmane conducted an improper turnaround by way of coming off the line and turning around. During the return set of steps, Deshmane again missed heel-to-toe and casually walked the final few steps.

The final exercise conducted, was the One-Leg Stand. During the exercise, Deshmane raised his left foot. Deshmane swayed throughout the exercise and raised his arms more than six inches from his sides. Deshmane also placed his foot down twice and hopped three times. Deshmane also had to be instructed twice to look down at his foot.

Based on this Officers observations, Deshmane was placed under arrest at 0541 hours. At PBSO BAT this Officer requested Deshmane to provide a breath sample for the purpose of determining its alcohol content, to which he agreed to do so. At 0648 hours, he blew .192 and at 0651 hours, he blew .210.

Based on the results of the investigation, this Officer has probable cause to prove Mahesh Deshmane operated a motor vehicle, in the state of Florida, while under the influence of alcohol to the extent his normal faculties were impaired, while having an unlawful breath alcohol content, in violation of FSS 316.193(1)(C). The degree to which Deshmane was impaired by alcohol was in violation of FSS 316.193(4).
