The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 8/7/2021 at approximately 0119 hours, the defendant was observed traveling approximately 10mph in a 45 zone, also failing to maintain a lane. Upon Deputy Chapman's contact with the defendant, he observed bloodshot watery eyes, slurred speech and a strong odor of alcoholic beverage on her breath. Upon my arrival, I observed the same indicators and asked the defendant if she would complete SFSE's and she said yes. During the SFSE's, the defendant displayed several more indicators of impairment and was therefore arrested. I transported the defendant to CBT where she provided 2 lawfully requested breath samples of 0.170/0.172%BrAC, after a 20 minute observation period. I issued the defendant a DUI citation A6UW9EE for DUI greater than 0.150. The defendant identified herself via Kansas DL.
