Before me this date personally appeared BRUCE, ERIC (6212) who being first duly sworn deposes and says that on 24 day of April, (year) 2017 at 800 E HALLANDALE BEACH BLVD, HALLANDALE BEACH, FL 33009 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

THE DEFENDANT AND VICTIM WERE INVOLVED IN A TRAFFIC ACCIDENT ON 800 E HALLANDALE BEACH. I ARRIVED ON SCENE IN REFERENCE TO THE DEFENDANT POSSIBLY DRIVING UNDER THE INFLUENCE. UPON ARRIVAL I OBSERVED THE DEFENDANT IN THE DRIVER SEAT OF HER VEHICLE AND THE SOLE OCCUPANT. THE VEHICLE WAS STILL RUNNING AS SHE HAD THE KEYS IN HER POSSESSION. THE DEFENDANT HAD RED BLOOD SHOT EYES, SLURRED SPEECH, AND THE SMELL OF AN ALCOHOLIC BEVERAGE EMANATING FROM HER BREATH. THE DEFENDANT COULD NOT RECALL WHETHER OR NOT SHE

Probable Cause Affidavit

Before me this date personally appeared BRUCE, ERIC (6212) who being first duly sworn deposes and says that on 24 day of April, (year) 2017 at 800 E HALLANDALE BEACH BLVD, HALLANDALE BEACH, FL 33009 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

WAS IN A TRAFFIC ACCIDENT. WHEN EXITING HER VEHICLE, SHE HAD DIFFICULTY STANDING ON HER OWN. WHILE SHE WAS STANDING I NOTICED A DISTINCT 2" ORBITAL SWAY IN HER POSTURE. SHE EVEN COLLAPSED TO THE GROUND MOMENTARILY BEFORE NEEDING ASSISTANCE TO STAND AGAIN. HALLANDALE BEACH FIRE RESCUE RESPONDED TO TREAT THE DEFENDANT AND DID NOT DIAGNOSE ANY ISSUES WITH HER HEALTH. THE DEFENDANT ADVISED SHE HAD NO MEDICAL HISTORY, NO INJURIES, AND NO AILMENTS PREVENTING HER FROM PERFORMING ROAD SIDE SOBRIETY EXERCISES. AS SUCH SHE ADVISED SHE WAS WILLING TO PARTICIPATE IN THE EXERCISES BEING CONDUCTED BY OFFICER RODRIGUEZ. THE RESULTS ARE AS FOLLOWS:

HORIZONTAL GAZE NYSTAGMUS (HGN) - LACK OF SMOOTH PURSUIT IN BOTH EYES WHILE TRACKING. MOVE HEAD SEVERAL TIMES, WOULD LOOK STRAIGHT AHEAD AND DISREGARDED TRACKING. HAD A ONSET OF NYSTAGMUS AT APPROXIMATELY 30 DEGREES AND A SUSTAINED NYSTAGMUS AT MAXIMUM DEVIATION.

ONE LEG STAND- DROPPED HER FOOT ON THE NINTH COUNT, WHILE COUNTING OUT LOUD SHE SKIPPED SEVERAL NUMBERS AND SHE WAS UNABLE TO HOLD HER FOOT UP SIX INCHES CONSTANTLY.

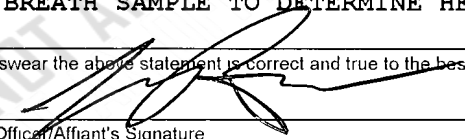
HEEL TO TOE- CONSTANTLY RAISED HER HANDS FOR BALANCE.

THE DEFENDANT WAS ARRESTED AND TRANSPORTED TO HALLANDALE BEACH POLICE HEADQUARTER'S TO AWAIT CLEARANCE FOR THE BATT FACILITY. ONCE CLEAR, SHE WAS TRANSPORTED TO THE BATT WITHOUT INCIDENT.

UPON ARRIVAL IMPLIED CONSENT WAS READ TO THE DEFENDANT AND SHE AGREED TO PROVIDE A BREATH SAMPLE TO DETERMINE HER BREATH ALCOHOL LEVEL.
