The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On 09/12/2020 at 0317 hours I conducted a traffic stop on a red Chevy Cruz sedan after I paced the vehicle at 55 MPH in a posted 40 MPH zone and also observed the vehicle drifting from side to side as it traveled westbound on Kennedy Bl W from Dale Mabry Hw N. Upon contact with the driver of the vehicle, defendant Maiya Bencosme, I observed that she had bloodshot and glassy and then as I explained to her why I had stopped her I detected a distinct odor of an alcoholic beverage. The defendant then admitted to having "a few drinks earlier". I then asked the defendant to perform the SFSEs and she refused. At which time I placed her under arrest for DUI based upon all of my observations made thus far in my investigation. The time of arrest was 0325 hours. I then transported the defendant to the HCSO/CBT Facility where she submitted to a breath test. Her BAC was .170/.175. I identified the defendant with a valid FL DL.
