

On Tuesday, September 10th, 2019 at approximately 1548 hours, Officer D. Concheso was dispatched to 600 Banyan Boulevard, West Palm Beach, Palm Beach County, Florida 33401 (West Palm Beach Police Department Front Lobby) in reference a delayed larceny. Upon arrival, Officer D. Concheso made contact with victim, Robert Landmesser who advised that his Rolex wrist watch was stolen on the night of September 6th, 2019 by a female, later identified as Makalia R. Ivey, black female, date of birth 04/06/1997.

At police headquarters, Landmesser advised that on the night of September 6th, 2019 at approximately 2300 hours, Landmesser was at 550 South Rosemary Avenue, West Palm Beach, Palm Beach County, Florida 33401 (Blue Martini) and met Ivey at the outdoor bar. After a few minutes of conversation between Landmesser and Ivey, Landmesser stated that he was tired and was leaving soon. Landmesser said that Ivey requested if she could walk him home which was approximately a couple street blocks away. Landmesser agreed, and Ivey and Landmesser began to walk home. At some point during the walk back home, Landmesser states that Ivey noticed his gold Rolex wrist watch. Ivey asked Landmesser do you mind if I try on try on the watch? Landmesser said yes and let Ivey wear the Rolex wrist watch back to his condo, located at 480 Hibiscus Street, West Palm Beach, Palm Beach County, Florida 33401 (City Palms Condominiums).

As Landmesser and Ivey enter the front lobby of City Palms Condominiums, security footage shows them entering the lobby at approximately 2344 hours. Landmesser and Ivey approach the front desk and check in with the front door security guard. Upon reviewing the security footage, the footage displays Ivey wearing the gold Rolex wrist watch on her right wrist. Once Landmesser and Ivey check in with the front desk employee, Landmesser and Ivey proceed to walk towards the lobby elevator. Landmesser and Ivey make their way up to the condo and have a drink. At some point within minutes of entering the condominium, Landmesser states that he passes out and falls asleep for an unknown amount of time.

On September 7th, 2019 at approximately 0002 hours, front lobby security footage displays Ivey walking back out of the same elevator by herself. As Ivey proceeds to walk past the front lobby desk, security footage again displays Ivey wearing the same gold Rolex wrist watch on her right wrist. Ivey is seen on security camera walking out the front door lobby doors in an unknown direction on Hibiscus Street.

At approximately 0100 hours, Landmesser advises that he wakes up and discovers that Ivey is gone with the Rolex wrist watch. Landmesser immediately heads back to Blue Martini in attempt to locate Ivey with his watch but was unsuccessful.


Landmesser described Ivey as a young black female, approximately 25-30 years old, black shoulder length hair, brown eyes, thin build, and last seen wearing a dark colored top with jeans.

The watch was described as a 1987 gold 18 karat Rolex wrist watch. The back of the watch has the engraving, "To Robert From Susan". Each numeral on the face has a single diamond and a circle of diamonds around the outer face. The band is 18 karat gold. Landmesser valued his watch at \$56,000.00. Let it be known that Landmesser has owned several jewelry businesses in the past and can estimate the market value of such items.

On Saturday, September 21st, 2019 at approximately 2313 hours, Landmesser states that he was back at Blue Martini and observed that Ivey was back at the outside bar. Landmesser said that he immediately called 911 and waited for police arrival. Officer C. Rekdahl arrived on scene and made contact with Landmesser just outside of Blue Martini. Landmesser advised Officer C. Rekdahl of the situation and requested Officer C. Rekdahl to make contact with Ivey. Officer C. Rekdahl made a consensual encounter with Ivey just outside of Blue Martini and gathered Ivey's credentials. Credentials included name, date of birth, and a Georgia driver's license number. Ivey left the area without incident.

On Wednesday, November 6th, 2019 at approximately 1000 hours, Landmesser responded to 600 Banyan Boulevard, West Palm Beach, Palm Beach County, Florida 33401 (West Palm Beach Police Department Criminal Investigation Division) and met your affiant in interview room 2025. Landmesser agreed to provide a sworn recorded statement. Prior to the statement, Landmesser raised his right hand and swore to tell the truth. Your affiant collected a sworn audio/visual recorded statement which reflected the above details. Interview was downloaded to West Palm Beach Police Department Evidence.com.

At approximately 1030 hours, Detective J. Eick responded to our location in reference presenting a suspect photo lineup of the defendant. Detective J. Eick read off the West Palm Beach Police Department Eyewitness Identification Instructions per F.S.S. 92.70. Landmesser signed the instruction form and stated that he understood all the


