The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 The defendant was operating a silver 2019 Jeep Renegade, 4 door, Florida tag 1BKA35. The defendant drove in a manner in which the vehicle tires drifted onto and over painted lane markers numerous times, and the vehicle straddled painted lane markers several times. The defendant drove at speeds that were visually estimated and patrol car paced (TPD unit 5055) at 54 MPH in a properly posted 40 MPH speed limit and 47 MPH in a properly posted 30 MPH speed limit. The defendant stopped a steady red traffic light, then proceeded into the intersection by failing to remain stopped for a steady red traffic light. A traffic stop was initiated. The defendant was slow to respond to the indication given to stop, then stopped in the right lane of the two westbound lanes rather than turning onto a cross street or into a parking lot. The defendant lit and began smoking a black and mild cigarette when I approached the vehicle. The defendant had a distinct odor of an alcoholic beverage on her breath. The defendant's eyes were bloodshot and watery, and her cheeks were semi-flushed. The defendant wore a light blue paper bar admissions band on her right wrist. The defendant stated she drank "one cup" of wine tonight. The defendant displayed some moderate sway while standing. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and displayed great difficulty following simple instructions. The defendant was arrested for DUI. The defendant provided breath samples of .140% BrAC and .143% BrAC. The defendant was positively identified by her FL DL.
