at approximately 12:30 AM, at 1400 GANDY BLVD N #608, in Pinellas County did:

BY USE OF A DEADLY WEAPON, TO-WIT: A GLASS BOTTLE, DID KNOWINGLY AND INTENTIONALLY CAUSE BODILY HARM TO BRYAN RATCLIFFE BY STRIKING HIM OVER THE HEAD WITH A GLASS BOTTLE.

THE DEF AND VICTIM ARE IN A DOMESTIC RELATIONSHIP. THE DEF WAS IN A VERBAL ARGUMENT WITH THE VICTIM IN THE LIVING ROOM OF THEIR APARTMENT. THE DEF STRUCK THE VICTIM IN THE HEAD WITH A GLASS BOTTLE. THE GLASS BOTTLE SHATTERED ON THE VICTIM'S HEAD AND LEFT A ROUND RED MARK. THE DEF DID NOT DENY HITTING THE VICTIM IN THE HEAD AND STATED SHE WAS NOT SURE HOW THE BOTTLE BROKE. THE VICTIM ALSO HAD ADDITIONAL RED MARKS ON HIS NECK WHERE THE DEF PLACED HER HANDS ON HIS NECK TO TRY TO CHOKE HIM. THE DEF ALSO HAD INJURIES TO HER HANDS AND NECK THAT WERE NOT CONSISTENT WITH HER STORY.


ADVISORY AND SOLVENCY HEARING

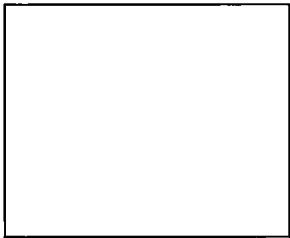
- A. Defendant has advised the Court that he has retained counsel or will retain counsel.
