The defendant was driving a white 2013 Mercedes two-door bearing a Florida license plate of IBA9I. She was traveling north on S MacDill Ave and ran the steady red light at Kennedy Blvd, striking the victim's vehicle and causing property damage and minor injury to the victim. The defendant was positively identified as the driver at the time of the crash. Upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, an odor of an alcoholic beverage, unsteady stance, and an admission to consuming alcohol. The defendant refused to perform SFSE. The defendant was arrested for DUI and later refused to submit to a breath despite acknowledgment of the Implied Consent Warning.

The defendant was identified by her FL DL.
