The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was observed to be driving a blue 2017 Kia NB on I-275, in the SB lanes near I-4 (head-on into traffic, the wrong way). After attempting a traffic stop, the defendant was slow to react and continued to drive NB, until coming to a complete stop just north of Sligh Av E. During the traffic stop, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, largely dilated pupils, blank/dazed stare, slurred speech, poor balance, slow deliberate movements, fumbling fingers, he was confused & disoriented (he thought he was driving home to Plant City), inability to formulate full/complete sentences, was in possession of several opened alcohol containers (beer & canned margaritas), ad emitted a distinct odor of an alcoholic beverage form his breath. He was arrested for DUI following a refusal to participate in SFSEs upon my request. While at CBT, he provided 2 valid breath samples, measuring .249/.234 BrAC.
