The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 07/27/2020, at approximately 2237 hours, I conducted a traffic stop at the intersection of 41 Hw N. and Harbor Vlg Ln, Apollo Beach, FL 33572. I conducted the traffic stop due to the blue in color, Fiat(LLUW59/VIN:JC1NFAEK8K0143251) travelling seventy miles per hour in a fifty-five miles per hour speed limit zone. When I made contact with the defendant, I observed him to have watery/glassy eyes, and the odor of an alcoholic beverage emitting from his breath. The defendant elected to perform the standardized field sobriety exercises, and doing so, I observed more indicators of impairment. At Central Breath Testing, at Orient Road Jail, the defendant refused to provide lawful breath samples after implied consent was read. The defendant identified himself via Florida driver's license.
