On Tuesday, 01-19-21, Deputies and I responded to 9325 Old Pine Road Boca Raton, FL 33428 at approximately 1451hrs, in reference to the report of a domestic assault. Upon arrival, contact was made with the complainant/victim, W/M Christian Ioszpe DOB: 10-03-79, who informed me of the following:

Christian Ioszpe advised that he and his wife/defendant, W/F Marcia Martins DOB: 02-04-61, were involved in a heated verbal argument that essentially turned physical. Christian Ioszpe informed me that prior to the arrival of Deputies, he attempted to separate himself from the argument with his wife by attempting to lock himself in his office. While attempting to do so, Marcia Martins interjected her body between the door and the door lock, which prevented Christian Ioszpe from securing the door. As Marcia Martins blocked Christian Ioszpe from securing the office door, she attempted to physically push him backwards so that she may gain entry into the office and aggravate the situation. Christian Ioszpe was essentially able to block his wife from gaining entry into the office and secured the office door with its locking mechanism.

Shortly after being locked out of the office, Marcia Martins took it upon herself to contact her acquaintance/defendant #2, W/M Silvano Rocha DOB: 11-28-78. Silvano Rocha responded to the above address at the request of Marcia Martins and inserted him into the domestic dispute at hand. Marcia Martins allowed Silvano Rocha into the residence and asked him to "break down" the office door in which Christian Ioszpe had barricaded himself in. Silvano Rocha then kicked the office door multiple times until it was shattered open. Christian Ioszpe informed me that he pleaded with Silvano Rocha multiple times not to break open the door and that he would contact Law Enforcement if he did so. Once the door was breached by force, Christian Ioszpe contacted PBSO to report the incident. All parties then separated until Deputies arrived on scene. Christian Ioszpe advised that he was in fear for his life during the office door being breached by Silvano Roche. I reviewed cell phone video of the incident and determined that Christian Ioszpe's allegations were in fact consistent with his cell phone footage. While on scene I attempted to gather a statement from Marcia Martins at which point she became uncooperative with my investigation.

Once I concluded my investigation, probable cause was established to arrest Marcia Martins for domestic battery pursuant to FS. 784.03(1)(a)(1) and also to arrest Silvano Rocha for simple assault pursuant to FS. 784.011. Both Marcia Martins and Silvano Rocha did intentionally and unlawfully threaten by word or act to do violence to the person of Christian Ioszpe coupled with an apparent ability to do so, and did create a well-founded fear in Christian Ioszpe that such violence was imminent,

Silvano Rocha was released on scene with a signed notice to appear (no domestic relation). Marcia Martins was transported to the Palm Beach County Jail without further incident.
