The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 The defendant was driving a white Jeep SUV bearing FL tag KFWZ20. The defendant was exiting the drop off area of Raymond James Stadium attempting to enter Dale Mabry Hw N, south of MLK Bv W, when he rear ended a bus causing approximately \$3000 in damage. The witness observed the crash and identified the defendant as the driver at the time of the crash. Upon police contact, the defendant was found to be passed out behind the wheel. Upon my contact with the defendant, he was located behind the wheel of his vehicle. The defendant exhibited indicators of impairment to include bloodshot and glassy eyes, thick slurred speech, the odor of an alcoholic beverage emanating from his breath, unsteadiness on his feet, and confusion. The defendant agreed to speak with me post Miranda. The defendant admitted to driving and having "3" drinks. The defendant participated in SFSE's which showed further indicators of impairment and was subsequently arrested for DUI.

The defendant provided breath samples of .239 / .232 .

The defendant was ID'ed via FL DL.
