SENT THE VICTIM THOMAS KELLY AN EMAIL DISCUSSING PERSONAL DETAILS OF THEIR FORMER RELATIONSHIP. THE VICTIM PROVIDED A PAPER COPY OF THIS EMAIL. ON 5/8/2020 THE DEF. CAME TO THE SPPD FOR AN INTERVIEW. POST MIRANDA, THE DEF. ADMITTED SHE SENT THE EMAIL BECAUSE THE VICTIM WAS CONTACTING HER AND SHE WANTED HER BELONGINGS BACK. THE DEF. ALSO SHOWED ME HER PHONE WHICH STILL HAD THE EMAIL MESSAGE FROM HER GMAIL ACCOUNT ON IT. I SAW THE EMAILS BETWEEN THE ALLEGED VICTIM AND DEF. THE ALLEGED VICTIM HAS BEEN CONTACTING THE DEFENDANT. ONE OF THE ALLEGED VICTIM'S EMAILS TO THE DEF. WAS THAT HE WAS "KINKY HORNY" AND OTHERS WERE "PLEASE DON'T LEAVE ME". ANOTHER EMAIL FROM THE VICTIM TO THE DEF WAS "STOP SUCKING HIS DICK...". EVEN THOUGH THE VICTIM HAD AN INJUNCTION AGAINST THE DEF, HE CONTINUED TO COMMUNICATE WITH THE DEFENDANT.

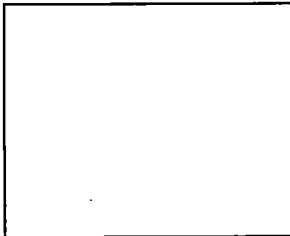
