The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was stopped for violation of multiple stop signs, running over a curb, and weaving back and forth in her lane. The defendant was driving her 2016 Toyota Corolla, bearing FL tag #1ILL55. Upon making contact with the defendant, she displayed multiple signs of impairment, including: bloodshot/glassy eyes, a strong odor of an alcoholic beverage on her breath, fumbling fingers, difficulty dividing her attention, swaying, urinating on her self, and an admission to consuming alcoholic beverages. The defendant exhibited multiple clues of impairment during the SFSEs and was arrested for DUI. The defendant later submitted to the breath test, which had a BrAC of .152/.142. A search of the defendant's purse incident to her arrest, revealed she was in possession of two small baggies and a small plastic jar, a white powdery substance, which had the appearance of powder cocaine. The substance also field tested positive for cocaine. Affiant also located a prescription bottle in the center console, which was in the name of Daniel Rodgers. The bottle contained 1 small round blue pill marked "C1" (identified via drugs.com as Clonazepam 1 mg) and 3 and a half octagonal white pills marked "M 15" (identified via drugs.com as Amphetamine and Dextroamphetamine). Both drugs are scheduled controlled substances for which the defendant does not have a prescription. The defendant identified herself via her FL Driver's license.
