The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 2/17/2021 at approximately 0217 hours, the defendant was involved in a 2 vehicle traffic crash. The defendant was operating a 2019 Hyundai Elantra bearing FL tag ID39BY (VIN:KMHD84LF8KU877618) when she struck the side of the victims vehicle. The 2 vehicles involved both have disabling damage. The total damage is estimated approx. \$15,000.00. The defendant advised she was coming from the Bottle House Bar where she had consumed 3 beers. The admission of alcoholic beverage consumption plus bloodshot watery eyes and strong odor of alcoholic beverage emitting from her breath, I requested she perform SFSE's. During the SFSE's, the defendant displayed several more indicators of impairment and was subsequently taken to CBT. Once at CBT, the defendant provided 2 lawful breath samples of 0.154/0.157%BrAC, after a proper 20 minute observation period. I issued the defendant DUI citation A4O42ME for DUI over 0.15 (with property damage). The defendant identified herself via FL DL.
