The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

On 6/14/2020, at approximately 0241 hours, at Lemon Wood Ct. / Citrus Pointe Dr., Tampa, FL 33625, Deputy Kleiner (ABN 255453) conducted a traffic stop on a silver Ford Fusion (bearing FL tag 0108XP / VIN: 3FAHP07ZX8R273595) for failure to obey a traffic control device (FSS 316.074(1)), when he observed the vehicle stop beyond the white stop bar on the roadway. Upon making contact, Deputy Kleiner observed the defendant to have glassy, bloodshot, watery eyes, slurred speech, and the odor of an alcoholic beverage was emitting from the defendant's breath. Based on the observed indicators of impairment, Deputy Kleiner requested a DUI investigator respond to the scene. Upon my arrival, I observed the same indicators of impairment listed above. The defendant was given the opportunity to perform field sobriety exercises, which she did poorly, indicating impairment. Subsequent to arrest, the defendant provided breath samples of .127/.126 after a twenty minute observation period. The defendant was identified via their Florida driver's license.
