The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was driving a blue 2019 Hyundai SUV bearing a Florida license plate of NRQF69. She was traveling west on Kennedy Blvd between Armenia and Dale Mabry and the vehicle was weaving back and forth. Then traveled north on Dale Mabry and came to a stop for a red light at W Gray St and stopped with 3/4 of the vehicle over the stop bar. The vehicle soon continued north on Dale Mabry and was weaving back and forth, and paced traveling 58 MPH in a posted 45 MPH zone. A traffic stop was made and rather than pulling over to the right, or into an open parking lot, the vehicle pulled into the center turn lane on Dale Mabry and stopped. Upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, an odor of an alcoholic beverage, and an admission to consuming alcohol (one glass of wine). The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later submitted to a breath test which had a BrAC result of .134 and .131. The defendant was identified by her FL DL.
