Body worn camera and in car video were used.</p> <p>Ofc Hennessy said he observed the vehicle, a Hyundai sedan (Y82KZY/FL) in the area of PGA Blvd and Prosperity Farms Rd, PBG, FL traveling west bound and failing to maintain a single lane. Ofc Hennessy stopped the vehicle at the location. This Officer made contact with the driver, identified via Florida Driver License photo, Maria Dewitt (OF) while she was still in the driver seat of the vehicle which was on and running. Dewitt appeared to avoid eye contact with this Officer. Dewitt had a flushed face, low heavy eye lids and watery red eyes. This Officer was able to detect the odor of an unknown alcoholic beverage emanating from Dewitt's breath at conversational distance. Dewitt's passenger answered most questions for her. Dewitt's passenger, her daughter, Gabriela Kaviany (IO) answered most of this Officer's questions in lieu of Dewitt. Kaviany said the two were coming from "Angry Moon" and on their way home to the area of Northlake and Military. Kaviany said Dewitt had consumed one Martini.</p> <p>Based on this Officer's observations, Dewitt was asked to participate in Standardized Field Sobriety Exercises, to which she complied. Dewitt only mentioned a foot condition which would affect the exercises.</p> <p>The first exercise conducted, was the Horizontal Gaze Nystagmus. The stimulus used, was a Toxoptix X3, with an illuminated red light. This Officer observed lack of smooth pursuit in both eyes. This Officer also observed sustained involuntary jerking in both eyes at maximum deviation, also this Officer observed the onset of Nystagmus prior to 45 degrees in both eyes. Dewitt had vertical gaze Nystagmus in both eyes.</p> <p>Jupiter PD Ofc Tappin #367 arrived on scene to assist with translation for the remainder</p>



The next exercise conducted was the One-Leg Stand. During the exercise, Dewitt raised her right foot. Dewitt was told to raise her left foot due to her injury, however still raised her right. Dewitt swayed throughout the exercise and kept her arms raised more than six inches from her sides. Dewitt placed her foot down three times, thus the exercise was terminated early.

The next exercise conducted, was the Finger to Nose. During the exercise the following observations were made: first command of Left, Dewitt touched under her nose then brought her hand out and touched again, second command of Left, Dewitt touched over the tip of her nose and then under, the next two commands of Right, Dewitt touched under her nose, the final command of Left, Dewitt used the pad of her finger. On all commands, Dewitt had to be told to lower her hand.

The final exercise conducted, was the Modified Rhomberg Balance. During the exercise, Dewitt estimated the passage of 30 seconds, in approximately 32 seconds.

Based on this Officer's observations, Dewitt was placed under arrest at 0126 hours. At PBSO BAT, this Officer requested Navarro to provide a breath sample for the purpose of determining its alcohol content, to which she complied. At 0225 hours, she blew .118 and at 0228 hours, she blew .116.

Based on the results of the investigation, this Officer has probable cause to prove Maria Dewitt knowingly operated a motor vehicle, in the state of Florida, while under the influence of alcohol over the legal limit, in violation of FSS 316.193(1)(C).
