The following incident occurred in the City of Delray Beach, Palm Beach County, FL: On March 4, 2022, at approximately 1532 hours, members of the Delray Beach Police Department's TACT team to include Ofc Kyotikki and I were on patrol in a marked DBPD vehicle in the 300 block of NW 3rd St. While on patrol, I observed a white female, later identified as Mariah Applegate via DBPD Records Management System, crouched down in the alleyway to the rear of Daughter of Zion Junior Academy, 250 NW 3rd Ave. Due to this, Ofc Kyotikki and I exited the patrol vehicle in our full police uniforms and went to make contact with Applegate for a welfare check. While approaching her, I could observe a plastic bag with an unknown powder on it in Applegate's hands. Applegate then lifted her head, observed Ofc Kyotikki and I, and immediately shoved the plastic bag into her purse which was on the ground next to her. Due to the above, I searched the location where I observed Applegate shove the plastic bag with the powder. From there, I retrieved the bag which contained half of a blue pill and powder consistent with the color of the pill. Also, in the same compartment as the bag was a Krazy glue container and a glass pipe with both ends burnt and metal wool. Inside of the Krazy glue container were two white rock like substances. From my training, experience, and knowledge I suspected the white rock like substance to be a crack cocaine and the glass tube to be a crack pipe. Ofc Kyotikki later field tested the suspected crack cocaine utilizing a NIK cocaine test kit which rendered a positive reaction. Ofc Kyotikki also field tested the blue powder using a NARK Fentanyl test kit which rendered a positive reaction for fentanyl. Ofc Kyotikki then asked Applegate if she had anything else on her to which she stated a crack pipe which she removed from her back right pant pocket. While doing a more thorough search of Applegate's purse after she was arrested, Ofc Kyotikki located a capsule with a tan powder at the bottom of the purse and another crack pipe in the

outside pouch to the purse. From my training, experience, and knowledge I suspected the tan powder to be fentanyl which Ofc Kyotikki later field tested utilizing a NARK fentanyl test kit which rendered a positive reaction. While at DBPD, I read Applegate her Miranda Warnings which she stated she understood. Post-Miranda Warnings, Applegate stated she did not know what the pill she had crushed up was, or what the pill was for. Due to the above, Probable Cause exist to charge Mariah Applegate with Possession of Cocaine, pursuant to FSS 893.13(6A), Possession of Fentanyl, pursuant to FSS 893.13(6A), and Possession of Drug Paraphernalia, pursuant to FSS 893.147(1).
