 committed the below acts in my presence. was observed by **Annie Dugars** who told **D/S Harper ID#7643**
 confessed to _____ that he/she saw the arrested person commit the below acts
admitting to the below facts _____ was found to have committed the below acts, resulting from my (described) investigation.
On the **10th** day of **February** 20 **20** at **17:30** A.M P.M (Specifically include facts constituting cause for arrest.)

On the above date and time, Kasha Edwards and Jamie Cofer did knowingly commit the offense of Grand Theft based upon the following: Edwards, and Cofer entered the JC Penny's located at 10308 W. Forest Hill Blvd. in the Village of Wellington, FL. Once inside the business, Edwards and Cofer selected Several Sephora makeup items worth approximately (\$867.24). Unbeknownst to Edwards and Cofer they were being observed via CCTV by Loss prevention officer Annie Dugars. Due to Dugar's training and experience, she believed that Edwards and Cofer had, were in the process of, or were about to commit a retail theft.

Dugars then watched as Edwards and Cofer worked into concert to conceal the items in Edwards' purse, and then attempted to walk past all points of purchase making no attempt to pay. Dugars confronted Edwards and Cofer before they made it out of the store, at which time they relinquished the stolen items and admitted to the theft. Edwards and Cofer were detained, at which point Dugars brought them back to the loss prevention office where she notified Mall Security of the theft.

Upon my arrival, I informed Edwards and Cofer that they were under arrest for retail theft. Dugars then provided me with a receipt showing the value of the items that Edward and Cofer attempted to take, a sworn witness statement, and a compact disc showing the crime in progress.

Once I received these items, I relocated Edwards and Cofer to the mall security office to complete arrest paperwork. Once inside the mall office, Edwards and Cofer were formally trespassed from the Mall at Wellington Green and its surrounding properties by PSC Officer Gentry. It was made clear to Edwards and Cofer that if they returned to the property on or before 02-11-2021, they risked being arrested for trespass after warning.

I believe the aforementioned facts form the probable cause necessary to charge Edwards and Cofer with grand theft pursuant to F.S.S. (812.014) (2c1).
