DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

The following occurred in the City of Delray Beach, County of Palm Beach, FL.

On 09/12/20 at 1936hrs Ofc. Masi #1134 DBPD observed a black 2017 Infiniti QX30 (FL Tag #M777M) traveling westbound on W. Linton Blvd. just west of S. Federal Hwy. Ofc. Masi observed the Infiniti leave and re-enter the inside travel lane several times. The Infiniti struck the center median curb and continue westbound. Ofc. Masi conducted a traffic stop in the 700 block of W. Linton Blvd. Ofc. Masi activated his emergency lights and siren on his marked Delray Beach Police Department patrol vehicle. The Infiniti ignored the emergency lights and siren and drove to the intersection of SW 10th Ave. The Infiniti made a left turn (south) onto SW 10th Ave. and then turned right into the Target parking lot located at 1200 W. Linton Blvd. The Infiniti continued driving through the parking lot and turned right (east) and entered a parking space. The Infiniti did not stop in the parking space before striking the concrete parking stop. The Infiniti was parked sideways while partially in two parking spaces. I arrived in the Target parking lot and met with the white female driver. I identified the white female driver by her FL DL as Marina Borisovna Mac Millan. Mac Millan was sitting in the driver seat with the engine running. The Infiniti's key was in the ignition. Mac Millan was the only person inside the Infiniti. Mac Millan was hysterically crying when I met with her. I told to take some deep breaths and attempt to calm down.

OBSERVATION OF DRIVER:

Mac Millan was hysterically crying when I met with her. I told to take some deep breaths and attempt to calm down. I informed Mac Millan I was on scene to conduct a DUI investigation and Mac Millan stated she understood. I had to tell Mac Millan several times to try to calm down due to her excessively crying. I smelled a strong odor of an unknown alcoholic beverage coming from her person. Mac Millan has red eyes and were glassy. Mac Millan had difficulty maintaining her balance when she exited the Infiniti. Mac Millan later took her shoes off during roadsides and still had difficulty maintaining her balance. Mac Millan swayed while standing still.

DRIVER'S STATEMENTS:

Mac Millan denied consuming any illegal drugs, prescription or over the counter medicines. Mac Millan stated she did not have any medical conditions or injuries that would hinder her ability to operate a motor vehicle. Mac Millan stated she left her friend's residence in Boca Raton, FL. and was on her way home when the traffic stop was conducted. Mac Millan stated she consumed one glass of wine at her friend's residence and finished the glass of wine two hours prior to the traffic stop. I asked Mac Millan if she knew why she was stopped by the police and she replied that she was driving too fast. I informed Mac Millan she struck a median curb and she did not give reason why she struck the curb. Mac Millan cried while being questioned. Mac Millan agreed to perform roadside tasks but would not follow my instructions. After being placed under arrest, Mac Millan stated she was not a criminal and did not do anything wrong. While being transported to the PBCJ BAT, Mac Millan was screaming and yelling accusing me of being a racist and I only arrested her because I was happy with my family.

ODORS:

Mac Millan had a strong odor of an unknown alcoholic beverage coming from her person.

Other Observations:

Mac Millan swayed while standing still during the HGN/VGN roadside. Mac Millan stopped following the stimulus light and had to be instructed several times to follow the light with her eyes. Mac Millan also turned her head side to side during the HGN/VGN roadside.

WALK & TURN:

Mac Millan swayed while standing still. Mac Millan performed this roadside with no shoes on. Mac Millan would not follow instructions while being placed in the instructional phase position. Mac Millan began walking several times before being instructed to begin walking. I had to stop the roadside several times due to Mac Millan not following my instructions to stand still while I demonstrated the roadside. Mac Millan stated she understood my instructions and began the roadside. Mac Millan used her arms for balance and did not touch heel to toe on either step. Mac Millan did not count each step as instructed. Mac Millan took too many steps on each series of steps. Mac Millan did not turn around as instructed.

ONE LEG STAND:

Mac Millan swayed while standing still. Mac Millan stated she understood my instructions for the roadside. Mac Millan began the roadside by bending over and touching her toes. I had to instruct Mac Millan to raise her leg off the ground as instructed. Mac Millan raised her leg off the ground and used her arms for balance. Mac Millan put her foot down on the ground before being instructed to do so.

FINGER TO NOSE:

Mac Millan swayed while standing still. Mac Millan stated she knew her left from her right. Mac Millan did not keep her eyes closed and her tilted back as instructed. Each time I gave an instruction of left or right, Mac Millan turned her head left and right and did not bring her index finger to her nose as instructed.

ROMBERG ALPHABET:

Mac Millan swayed while standing still. Mac Millan did not keep her head tilted back and eyes closed as instructed. I instructed Mac Millan to speak in a nonrhythmic manner. Mac Millan recited the alphabet A-Z fast and I was not able to hear each letter.

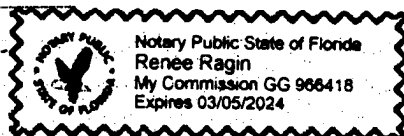

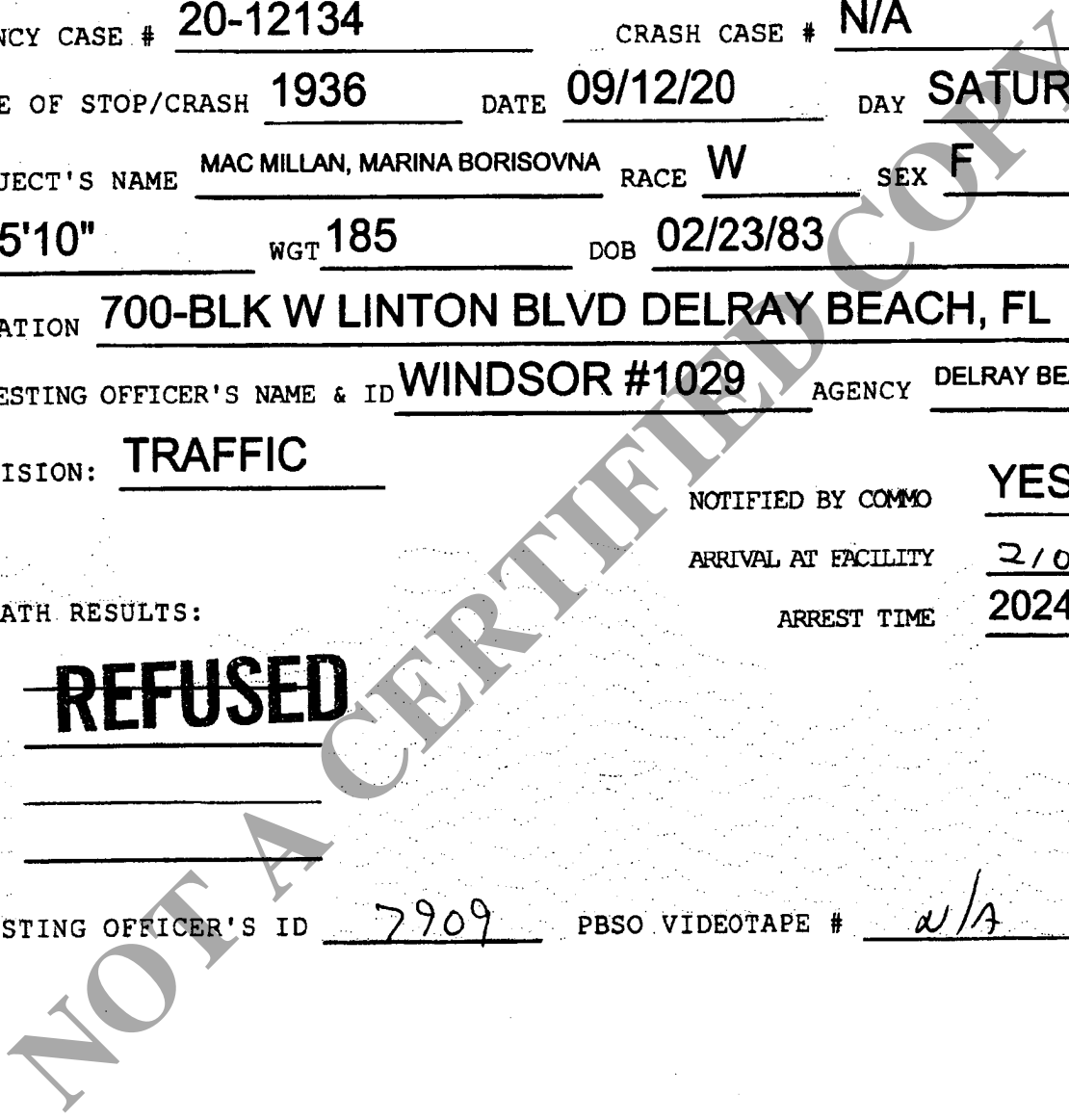
