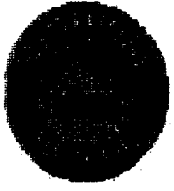

### Probable Cause

On Monday, July 13th, 2020, I Trooper Sayih #3822 along with Recruit Trooper Tomas #1820 were on routine road patrol. I was dispatched to a vehicle crash located northbound on Interstate 95 (State Road 9) south of Palmetto Park Rd.

When we arrived on scene I observed a silver in color Saturn disabled in the inside center lane. Once the roadway was clear R/T Tomas #1820 and myself made contact with the driver of the silver Saturn along with a couple witnesses. The witnesses advised us that they observed the silver in color vehicle traveling northbound and travel off the roadway onto the right paved emergency shoulder where it then collided into a message board. The silver in color vehicle then traveled back onto the roadway where it then came to a final rest in the inside center lane. The witnesses stated that after the crash they approached the vehicle and observed a female in the driver seat along with no other occupants, who they assisted out of the vehicle (See Witness Statements). The driver of the vehicle who was later identified as Marinea Granville 04/30/1995, through her name and date of birth. Ms. Granville stated that all she recalled from the accident was traveling northbound from her friends house in Pompano Beach and falling asleep as she was driving. As Ms. Granville was explaining what had happened, her speech was very slurred and she was swaying as she was standing. Her eyes were also bloodshot and watery. Ms. Granville was then advised that the crash investigation was concluded and that a criminal DUI investigation would now be conducted. Ms. Granville was requested to perform a series of roadside exercises to which she consented to perform (See Roadside Tasks Sheet).

The area for the following roadside exercises was level. Subject was then asked if she had any problems with her eyes aside from corrective vision, or injuries that would prevent her from performing any of the exercises that will be requested of her to perform. Subject then advised me that she did not have anything were nor physical body injuries or limitations and would be able to perform the exercises.

Ms. Granville was then searched and placed in my patrol vehicle where she was then transported to the Palm Beach County Jail's Breath alcohol testing facility (BAT). Inside the Palm Beach County Jail's breath alcohol testing facility (BAT) Ms. Granville began a 20 minute observation prior to being provided an opportunity to provide a breath sample. After Ms. Granville's 20 minute observation, she was given an opportunity to provide a breath sample in which refused to provide. Ms. Granville was then read implied consent and was given another opportunity to provide a sample of her breath to which she refused again at approximately 05:14 AM.
