On the above listed date and time, at the above listed location, Deputy Schaefer #250517, conducted a traffic stop on a yellow Ford F150 bearing Florida tag: KCMH11, due to the vehicle was weaving all over the road. Upon making contact with the defendant, Deputy Schaefer detected signs of impairment. I responded to the scene, detected the defendant to have glassy and bloodshot eyes and a distinct odor of an alcoholic beverage emanating from his breath. I requested the defendant to perform Standard Field Sobriety Exercises (SFSEs), which the defendant agreed to perform. During the exercises, the defendant showed multiple signs of impairment and was subsequently arrested for DUI. The defendant refused to provide two lawful breath samples to determine his breath alcohol content (BrAC). I read Implied Consent to the defendant in room #1 of Central Breath Testing, he understood and replied "I'm not blowing". The defendant received a DUI citation #A95009E, which reflects the DUI charge. The defendant was identified via his Florida Driver's License.
