PERSONAL CONTACT

DRIVING PATTERN: (Actual Physical Control; Physical Evidence or Statements Putting Defendant Behind Wheel of Vehicle)

Officer Keel #508 initiated a traffic stop after a gray Nissan Rouge bearing FL KYR53, failed to move over for a stopped emergency vehicle on PGA Boulevard, west of Central Boulevard. Officer Keel was just completing a traffic stop when the Nissan came close to him (lane next to him) at speed, not slowing down or moving over. This area of PGA Blvd is a three lane roadway. Officer Keel said the Nissan was the only vehicle traveling westbound on PGA Boulevard. Officer Keel made contact with the driver and sole occupant Marissa Balsome, identified via her FL driver's license.

OBSERVATION OF DRIVER:

Balsome had glassy eyes and the strong odor of an unknown alcoholic beverage coming from her breath as she spoke. She was animated while talking and boisterous. Balsome was wearing a tan tanktop, ripped jean shorts and black flip flops.

DRIVER STATEMENTS:

Stated she was coming from "Ronie's" or "Uncle Mick's" and had one Bud Light wither friends, "20 or 30 minutes ago." Later, Post-Miranda stated she had (1) Bee's Knees at Parched Pig between 6-6:30pm and then went to "Ralphs" where she had a Bud Light about 15-20min before the stop.

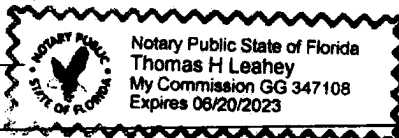

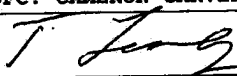

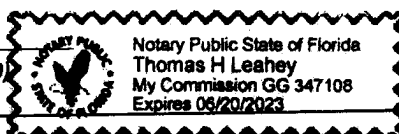
