ON 04/06/2016 AT OR ABOUT 1700 HOURS AT THE LOCATION OF 904 N 20TH AVENUE WHICH IS LOCATED WITHIN THE JURISDICTIONAL LIMITS OF THE CITY OF HOLLYWOOD, WITHIN BROWARD COUNTY AND THE STATE OF FLORIDA, THE ABOVE NAMED DEFENDANT DID COMMIT THE VIOLATION OF POSSESSION OF HEROIN. MARISSA KNUDSON DID HAVE IN HER ACTUAL POSSESSION A CONTROLLED SUBSTANCE, TO-WIT: HEROIN, IN AN AMOUNT OF LESS THAN FOUR GRAMS (4). Probable Cause Affidavit

Before me this date personally appeared RUIZ, DANIEL (3342) who being first duly sworn deposes and says that on 6 day of April, (year) 2016 at 904 N 20TH AV, HOLLYWOOD, FL 33020 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows
PRESUMPTIVE PRESENCE OF HEROIN. THE REMAINDER WAS SENT TO THE BROWARD COUNTY SHERIFF'S OFFICE LABORATORY FOR ANALYSIS.

I AM ASSIGNED TO HOLLYWOOD POLICE DEPARTMENT'S STREET CRIMES UNIT. I WEAR FULL POLICE TACTICAL UNIFORM WHICH INCLUDES THE WORD "POLICE" PROMINENTLY DISPLAYED ACROSS THE CHEST AND BACK OF A TACTICAL VEST, AND BOTH ARMS OF A LONG SLEEVE SHIRT, CLEARLY IDENTIFYING ME AS A LAW ENFORCEMENT OFFICIAL. I OPERATE AN UNMARKED POLICE VEHICLE EQUIPPED WITH EMERGENCY LIGHTS AND SIREN. ON THE ABOVE LISTED DATE AND TIME, DETECTIVE DJOKIC #3296 AND I WERE RIDING TWO MAN AND PATROLLING THE EAST SIDE OF HOLLYWOOD. ON OR AROUND 1700 HOURS, WE OBSERVED A SILVER 4 DOOR ACURA BEARING FL TAG# AKRM16 TRAVELING NORTH BOUND ON N 20TH AVENUE WHILE IN THE 600 BLOCK. WE NOTICED THROUGH THE LOWERED PASSENGER SIDE WINDOW THAT BOTH THE VEHICLE'S DRIVER AND FRONT SEAT PASSENGER DID NOT HAVE THEIR SAFETY BELTS FASTENED (CITATION # A1PTC6P AND CITATION # A1PTC7P).

THE VEHICLE PULLED INTO A PARKING SPOT FACING NORTH AT A BUSINESS ON THE NORTH EAST CORNER OF JOHNSON STREET AND N 20TH AVENUE (904 N 20TH AV), BEFORE WE COULD INITIATE A TRAFFIC STOP. WE APPROACHED THE VEHICLE ON FOOT IN ORDER TO MAKE CONTACT WITH THE OCCUPANTS. WHILE APPROACHING THE PASSENGER SIDE OF THE VEHICLE, I OBSERVED A WHITE FEMALE WHO WAS LATER IDENTIFIED AS MARISSA KNUDSON, TO BE IN POSSESSION OF A BLACK CLOTH BAG WHICH APPEARED TO CONTAIN SEVERAL SYRINGES WITH BRIGHT ORANGE CAPS. I THEN HEARD DETECTIVE DJOKIC GIVING THE OCCUPANTS LOUD VERBAL COMMANDS TO KEEP THEIR HANDS IN PLAIN VIEW AFTER OBSERVING SUSPECT NARCOTICS IN THE REAR SEAT OF THE VEHICLE. I THEN HAD THE REAR PASSENGER EXIT THE VEHICLE THROUGH THE REAR PASSENGER SIDE AWAY FROM THE SUSPECT NARCOTIC.

Before me this date personally appeared RUIZ, DANIEL (3342) who being first duly sworn deposes and says that on 6 day of April, (year) 2016 at 904 N 20TH AV, HOLLYWOOD, FL 33020 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

I THEN MADE CONTACT WITH MARISSA KNUDSON (FRONT SEAT PASSENGER) WHO ADVISED SHE ONLY HAD "EMPTY NEEDLES" AND STATED "YOU CAN CHECK" IN REFERENCE TO HER BLACK CLOTH BAG CONTAINING APPROXIMATELY 20 EMPTY SYRINGES. WHILE SEARCHING THE CLOTH BAG MARISSA KNUDSON SPONTANEOUSLY UTTERED "THERE MIGHT BE ONE HALF BAGGIE IN THERE". A SEARCH OF THE BAG LED TO THE DISCOVERY OF TWO 1" BY 1" CLEAR PLASTIC BAGGIES. ONE FULL BAGGIE CONTAINING AN OFF WHITE POWDER WHICH I BELIEVED TO BE SUSPECT HEROIN AND ANOTHER CONTAINING NON WEIGHABLE RESIDUE WHICH BOTH TESTED POSITIVE FOR THE PRESUMPTIVE PRESENCE OF HEROIN.

MARISSA KNUDSON WAS PLACED UNDER ARREST AND TRANSPORTED TO BSO MAIN JAIL VIA HPD FOR PROCESSING

A PROPERTY RECEIPT AND BSO LAB FORM WERE COMPLETED AND THE EVIDENCE PLACED INTO HPD PROPERTY.

DETECTIVE DJOKIC ULTIMATELY PLACED THE REAR PASSENGER (BRENDA BRAGG) UNDER ARREST FOR THE POSSESSION OF HEROIN AS WELL. SEE HIS REPORT FOR FURTHER (33-1604-062205).
