## **NARRATIVE:**

During the course of this investigation it was determined that the suspect, Mark Hannifin, responded to the victim's, Diana Gorelkin, residence on 12/15/14 as a sales representative for the Florida Door Shop. The purpose of the visit was to provide an estimate for the installation of windows for Gorelkin's residence.

During this visit Gorelkin advised Hannifin that she was in need of new window treatments for her residence as well. According to Gorelkin, Hannifin advised that she could purchase window treatments through him. Gorelkin advised that Hannifin made it appear that she would be purchasing the window treatments from the Florida Door Shop via Hannifin. Gorelkin was quoted a price of \$6,000 for the window treatments, agreed to purchase the treatments and provided Hannifin with a personal bank check for \$3,000 for a deposit in order to start the order process. Hannifin had Gorelkin make the bank check payable to Your Blind Shop, explaining that window treatments made through him for the Florida Door Shop were completed under the Your Blind Shop.

As of 02/05/15 Gorelkin has not received the window treatments she paid Hannifin for.

During the course of this investigation it was determined that Your Blind Shop did not exist until after Hannifin collected the \$3,000 from Gorelkin. Hannifin no longer works for the Florida Door Shop. According to the owner of the Florida Door Shop the business does not sell window treatments and there was never an agreement for Hannifin to sell window treatments while conducting business for the Florida Door

Shop. There is no documented record of a sale of any type to Gorelkin by Hannifin at the Florida Door Shop.

The victim in this case, Gorelkin, contacted the Palm Beach County State Attorney's Office (SAO) regarding this matter. A representative from the SAO contacted Hannifin and requested that the \$3,000 be returned to Gorelkin.

On 02/12/15 Gorelkin received via USPS mail a TD Bank check from Hannifin. The check was for \$3,000. In the top left corner of the bank check was written Your Blind Shop. The check was posted dated for 02/15/15.

On 02/17/15 Gorelkin had her bank (Chase) check the TD account the check was written against to verify if there were funds in the account. This was done at my suggestion prior to transacting the check in order to prevent Gorelkin from incurring any penalties if the check did not go through due to lack of funds. It was discovered that the TD bank account that Hannifin wrote the \$3,000 check against did not have the funds to cover the check. The decision was made to collect the TD bank check from Gorelkin and place it into PBSO evidence to preserve for any possible criminal prosecution.

On 02/19/15 a mirandized interview was conducted with Hannifin in which he admitted to collecting \$3,000 from Gorelkin and that he has yet to return Gorelkin's. Hannifin stated that he did not return Gorelkin's money because he believed it was owed to him by Gorelkin for services he provided to Gorelkin unrelated to the window treatements; however, he could provide no evidence of these services.

Hannifin admitted to issuing the TD Bank check to Gorelkin for \$3,000 as repayment. He admitted to knowing that there were insufficient funds in the TD Bank account and that check could not be transacted. During the interview Hannifin was asked if he knew the check was worthless and he stated that he did know the check was worthless when he issued it to Gorelkin.

Due to the prescribed facts outlined in this report in that Mark Hannifin admitted to did knowingly obtaining \$3,000 from the Diana Gorlekin in an effort to permanently deprive Gorelkin of the funds, it is believed that Mark Hannifin is guilty of and is charged with;

Grand theft per F.S.S. 812.014 (2c1)

Due to the fact Mark Hannifin knowingly and admittedly issued a check on TD bank account with clear knowledge that there would not be sufficient funds in the account at the time of issuance, it is believed mark Hannifin is guilty of and is charged with;



Giving worthless checks per F.S.S. 832.05 (2b)
