The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On Sunday, August 22, 2021, at approximately 02:30 am, at the Seminole Hard Rock Hotel and Casino - Tampa - located at 5223 Orient Road, Tampa, FL 33610, the Seminole Police Department (SPD) was called by casino security in reference to a battery that occurred on the gaming floor of the casino. I, SPD Officer A. Conran, responded to the casino security office, where I met with security, who advised that the defendant open-hand smacked a female casino employee on the buttocks, which was confirmed by the victim. The incident was also captured via casino video surveillance. This officer reviewed surveillance video, which reveals the defendant utilized his open left hand to strike the buttocks of the female casino employee, at approximately 02:04 am.

The defendant was positively identified as Mark Edward Taylor, date of birth: 03/20/1984, via his Indiana driver's license, bearing the number of 0580-60-6154.

This officer's investigation revealed that the defendant did actually and intentionally touch or strike another person, the female casino employee, against their will, by open-hand smacking her buttocks. The suspect was placed under arrest, handcuffed behind his back and double-locked. The defendant was subsequently transported to the Orient Road Jail without incident and booked in for the charge listed in this document.
