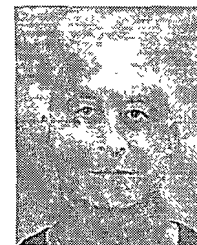

Probable Cause Affidavit

Before me this date personally appeared DOYLE, KRISTOPHER (3003) who being first duly sworn deposes and says that on 6 day of May, (year) 2017 at ██████████ (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

ON 05/06/2017 THE VICTIM ██████████ WOKE UP TO FIND HER 2007 BLUE TOYOTA FJ CRUISER TO BE DAMAGED. INSPECTION OF THE VEHICLE REVEALED THREE OF THE REAR WINDOWS TO BE SMASHED OUT, AND AN UNKNOWN SUBSTANCE WAS PUT ON THE PAINT WHICH CAUSED DAMAGE. ██████████'S RESIDENCE IS EQUIPPED WITH SURVEILLANCE CAMERAS WHICH CAPTURED THE INCIDENT.

THIS DETECTIVE WAS ABLE TO VIEW THE VIDEO FOOTAGE AND OBSERVED A MALE WEARING A HOODED SWEATER, SHORTS, AND SANDALS RUN UP TO ██████████'S VEHICLE WHICH WAS PARKED IN FRONT OF HER RESIDENCE. THE MALE IS OBSERVED WALKING AROUND THE VEHICLE SPRAYING AN UNKNOWN CHEMICAL ONTO THE PAINTED AREAS. WHEN THE MALE REACHES THE REAR OF THE VEHICLE, HE IS OBSERVED BREAKING THE THREE BACK WINDOWS WITH AN UNKNOWN OBJECT. THE MALE IS OBSERVED FLEEING NORTHBOUND ON 25TH AVENUE OUT OF THE CAMERAS VIEW.

██████████ WAS ABLE TO VIEW THE SURVEILLANCE VIDEO AND POSITIVELY IDENTIFIED THE MALE AS BEING MARK FALUGO. ██████████ WAS THE VICTIM OF A DOMESTIC VIOLENCE INCIDENT THAT FALUGO WAS PREVIOUSLY CHARGED WITH. SHE CURRENTLY HAS AN ACTIVE NO CONTACT ORDER, AND AN ACTIVE INJUNCTION REFERENCE COURT CASE NUMBER DVCE-16-1698 PROTECTING HER FROM FALUGO. THE FINAL JUDGEMENT INJUNCTION INDICATES THAT FALUGO IS NOT TO BE WITHIN 500 FEET OF ██████████'S RESIDENCE. WHEN FALUGO COMMITTED THE VANDALISM, ██████████'S VEHICLE WAS PARKED APPROXIMATELY 15 FEET FROM HER FRONT DOOR WHICH IS WELL WITHIN THE 500 FEET OF PROTECTION LISTED IN THE INJUNCTION.

ON 05/25/2017 THIS DETECTIVE MADE CONTACT WITH ██████████ AT THE HOLLYWOOD POLICE DEPARTMENT. SHE PROVIDED THIS DETECTIVE WITH A SWORN RECORDED STATEMENT GIVING HER ACCOUNTS OF THE INCIDENT. DURING THE STATEMENT SHE AGAIN POSITIVELY IDENTIFIED FALUGO,
