INSPECTION OF THE VEHICLE REVEALED THREE OF THE REAR WINDOWS TO BE SMASHED OUT, AND AN UNKNOWN SUBSTANCE WAS PUT ON THE PAINT WHICH CAUSED DAMAGE. S RESIDENCE IS EQUIPPED WITH SURVEILLANCE CAMERAS WHICH CAPTURED THE INCIDENT. THIS DETECTIVE WAS ABLE TO VIEW THE VIDEO FOOTAGE AND OBSERVED A MALE WEARING A HOODED SWEATER, SHORTS, AND SANDALS RUN UP TO TO SWEETER SHORT OF SANDALS RUN UP TO STANDARD SANDALS RUN UP TO SWEETER SHORT OF SANDARD SANDALS RUN UP TO SWEETER SANDARD SAN HER RESIDENCE. THE MALE IS OBSERVED WALKING AROUND THE VEHICLE SPRAYING AN UNKNOWN CHEMICAL ONTO THE PAINTED AREAS. WHEN THE MALE REACHES THE REAR OF THE VEHICLE, HE IS OBSERVED BREAKING THE THREE BACK WINDOWS WITH AN UNKNOWN OBJECT. THE MALE IS OBSERVED FLEEING NORTHBOUND ON 25TH AVENUE OUT OF THE CAMERAS VIEW.

WAS ABLE TO VIEW THE SURVEILLANCE VIDEO AND POSITIVELY IDENTIFIED THE MALE AS BEING MARK FALUGO. WAS THE VICTIM OF A DOMESTIC VIOLENCE INCIDENT THAT FALULGO WAS PREVIOUSLY CHARGED WITH. SHE CURRENTLY HAS AN ACTIVE NO CONTACT ORDER, AND AN ACTIVE INJUNCTION REFERENCE COURT CASE NUMBER DVCE-16-1698 PROTECTING HER FROM FALUGO. THE FINAL JUDGEMENT INJUNCTION INDICATES THAT FALUGO IS NOT TO BE WITHIN 500 FEET OF S RESIDENCE.
