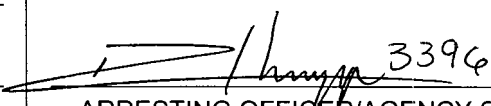

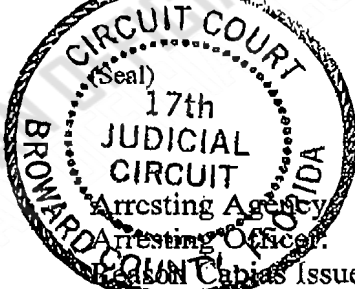

On December 19th, 2016 at approximately 1842 hours, I observed a silver Mercury with a Florida tag of BJAL11 driving south of Dixie Highway in Dania Beach. The vehicles tag light was not working and I conducted a traffic stop on the vehicle.

I made contact with the driver, identified as Mark Adler (DOB: 7/1/53), on the driver side and requested his information. While Adler was getting his drivers license and

Before me this date personally appeared COLON, JUSTIN (17189) who being first duly sworn deposes and says that on

19 day of December, (year) 2016 at 1400 DIXIE HWY, DANIA BEACH, FL 33004 (crime location)

the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

registration I could see a chunk of white rock like substance in his lap area (suspected crack cocaine) in plain view. I asked Adler if there was anything illegal in the vehicle and Adler immediately stated "no, no, no, I don't do drugs."

Adler continued to flip through the paperwork he had grabbed from the glove compartment and he was now holding it directly over where I observed the chunk of white rock like substance. I asked Adler to step out of the vehicle and he complied. As Adler stood up I could see the chunk of white rock like substance sitting on the seat. I conducted a field test of the chunk of white rock like substance and it provided positive results for the presence of cocaine base.

Adler was taken into custody at this time. A search of Alder revealed that he had an additional chunk of white rock like substance in the pocket on the front of his shirt. The chunk of white rock like substance from Adler's shirt field tested positive for the presence of cocaine base.

Due to the fact that Adler suffers from several medical conditions to include High Blood Pressure, and Diabetes, along with not have his medications on him at the time, an Out of Custody Arrest Affidavit was completed and submitted for Possession of Cocaine.

Additionally, Adler was issued a written warning citation for the tag light violation. The evidence recovered was collected and submitted to the BSO Crime Lab for analysis.
