The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On the above listed date and time, at the above listed location, the defendant and both witness were outside the defendant's patio area consuming alcohol. For unknown reasons, the defendant retrieved an unknown make and model pistol and fired 3 shots toward the ground. The defendant then returned into his residence and retrieved a Maverick model 88 12 Gauge Shotgun and fired one round. All of the defendant's actions were observed by both witnesses. While Deputy Narvaez #258671 was conducting an interview with the defendant, the defendant attempted to enter his residence. Deputy Narvaez gave multiple verbal commands to the defendant not to enter, to no avail. In plain sight, the Maverick model 88 12 Gauge Shotgun was resting within 5 feet from the rear sliding door of the residence. Both witnesses identified the defendant as the one who committed the offense. The defendant was identified via FL DL.
