The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 10/09/2020, at approximately 2254 hours, Corporal A. Whitted (ABN 97748) responded to a related wrong way driver call for service (HCSO case #20-650392) when he observed the matching vehicle, a black Dodge Durango, bearing Florida tag EHB2019. Corporal Whitted observed the Dodge Durango to be traveling in the center lane. This vehicle swerved to the left, back into the center lane and then to right, multiple times. Corporal Whitted conducted at traffic stop on this vehicle in the parking lot located at 11315 N 30th St. Uppno contact with the defendant, he had bloodshot glassy eyes, slurred speech and the distinct odor of an alcoholic beverage emitted from his breath as he spoke. The defendant was asked to participate in the Standardized Field Sobriety Exercises, which he refused. Based on the totality, the defendant was placed under arrest for DUI. Implied consent was read and the defendant refused to provide a lawful sample of his breath. The defendant was identified via his US Passport Card.
