The victim stated she asked her husband/offender, Mark Savage (W/M 12/04/1974, 508-612-1076) about their mortgage and insurance when he started to yell and argue with her. She said a short time later she asked him about going to get breakfast when he again started yelling at her because he did not like the suggestions she was making about which place to go to. The victim explained that the offender threw his shaker bottle at the front door which spilled all over the rug before going upstairs and arguing with her more inside her bedroom (the offender stayed/slept in a room downstairs). She told me the offender went into her bedroom closet and started throwing her purses into the bedroom.

The victim went on to say she ran into the closet and tried to push him away from her things so he would stop throwing her belongings. She said the offender pushed her to the ground with both hands. The victim explained that she got up quickly and ran out of the closet towards her bed to get away from him. She told me the offender walked towards her at which point she tried to push and kick him to keep him away from her.

The victim then stated the offender picked up her black Burberry handbag and struck her four times on the right side of her face near her eye with it. She said she told him she was going to call law enforcement at which point he backed away from her. The victim explained that the offender told her that if the police came, they both would be arrested and her children would be taken away from her (their two kids were at school and not inside the residence during the incident). She told me the offender left the residence before JPD arrival.

I observed red marks on the right side of the victim's face especially near her right eye. There was also bruising under her right eye that she stated was from a previous incident where she was attempting to break up a fight at a restaurant/bar. The victim's denim jacket was ripped on the right and left side that she explained was sustained during the physical altercation with the offender.

Contact was made with the offender via phone call. He stated he would not come back to the residence to give a statement, but said he would meet at the Jupiter Police Department. The offender arrived shortly after at JPD and stated the following: He stated the victim started complaining about money, then he threw a water bottle at the front door out of frustration. The offender explained there was no physical altercation between him and the victim. I observed a few scratch marks on the right side of the offender's neck that he told me was from wrestling with his son and from the incident.

Based on the statements and evidence along with my investigation, I find probable cause to charge the offender with Domestic Battery because he did actually and intentionally touch or strike the victim against the will of the victim (or) did intentionally cause bodily harm to the victim and the victim was a family or household member of the offender, contrary to Florida Statute 784.03(1), 741.28 and 741.283.
