Slorp Jr. did change his shirt and hat in an attempt to complete a second transaction at The Tractor Supply Store. This did fail due to the victim being notified of a thirty dollars was charged to her debit card at a nearby 7-11 store and canceled her debit card. This caused the second transaction with Slorp to fail.
