The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On the listed date, time, and location, the defendant and the victim were engaged in a verbal altercation within the master bedroom of the listed residence. The verbal altercation escalated when the defendant pushed the victim on the chest area with open hands. The defendant then struck the victim with closed fists on her outer left thigh. As the defendant was exiting the residence, he advised the victim that if she calls the police he would kill himself. The victim contacted law enforcement shortly after. The victim and defendant have been in a romantic relationship for two and a half years. The victim and defendant are currently married and have resided together as a family for eight months. The affiant did not observe any physical injuries on either the defendant or the victim. The victim positively identified the defendant as the person who committed the offense. The defendant positively identified himself verbally and via his Florida driver's license. The defendant did not wish to provide a statement post-Miranda. No firearms were utilized during the commission of this offense.
