(Specifically include facts constituting cause for arrest.)</p> <p>On July 31, 2021 at approximately 0045 hours, I responded to 10045 Belvedere Rd (Connolly's Sports Bar) in The Village of Royal Palm Beach, Palm Beach County in reference to a disturbance in progress. Upon my arrival multiple patrons point out a white male wearing a blue shirt in jeans walking away from the business.</p> <p>Patrons at the bar stated the male later identified as Mark Deegan, was stating he was going to kill everyone if they don't let him back into the bar. Contact was made with the bartender, Caitlyn Gross, who stated that she asked Mark to leave multiple times as he was very intoxicated and yelling at customers and trying to fight with them. Mark constantly refused to leave the bar after being asked multiple times to leave. Mark continued to try to fight with customers, making threats and causing a disturbance. She and other patrons were finally able to get Mark to get outside. Once outside the property he was asked to leave again, to which he refused and continued to be belligerent. Patrons began to leave the bar and were disturbed by this behavior. Caitlyn provided me with a sworn written statement of these events.</p> <p>Upon my arrival, I stepped out of my fully marked patrol car while wearing a full PBSO patrol uniform and told Mark to stop walking away and come over to me. Mark instead continued to walk away and refused my commands. I followed Mark over to the 7-11 convenience store and was finally able to stop him. Upon doing so, I detected the odor of unknown alcoholic beverage emanating from Mark's breath and body. Mark was also barely able to stand up and was swaying back and forth. I asked Mark why was he causing a disturbance which he replied "Go Fuck yourself".</p> <p>Contact was then made with off-duty D/S J. Callahan #7387, who was on scene and witnessed the entire event. D/S Callahan advised that the subject had been causing an extensive disturbance in the bar, was threatening patrons, and then escalated into threatening to kill everyone in the bar. He observed Mark kick another patron in the groin and try to fight with other patrons, refusing numerous orders to leave the bar issued by the bartender.</p> <p>Based on my investigation, I determined that Mark Deegan did commit the following criminal acts:</p> <p>Disorderly intoxication - by being intoxicated by alcoholic beverages and threatening the public as well as causing a public disturbance, pursuant to FSS 856.011(1).</p> <p>Trespassing in an Occupied Structure - by knowingly and willfully occupying Connolly's Sports Bar and being asked to leave the establishment multiple times by the employees and then refusing to leave, pursuant to FSS 810.08(2)(a).</p> <p>Resisting Officer without Violence - by knowingly and willfully refusing my lawful commands to stop, with the intent to hinder/obstruct/delay/oppose my investigation, pursuant to FSS 843.02.</p> <p>STATE OF FLORIDA COUNTY OF PALM BEACH</p> <p style="text-align: right;">D/S M.
